

#### **4. ULTIMATE PARENT COMPANY**

From 1 January 2004 to 31 March 2004, the ultimate parent company and controlling party was Coats Group Limited, a company incorporated in the British Virgin Islands.

The smallest group of which this Company is a member and for which consolidated accounts are prepared is Coats Holdings Limited, a company incorporated in England and Wales.
