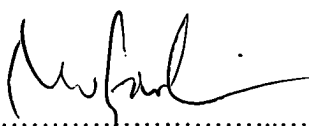
For the year ended 31st December 2014 the company was entitled to exemption under section 480 of the Companies Act 2006.
