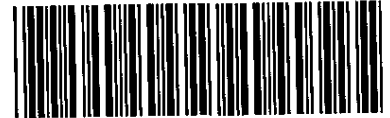

AND UPON the solicitors for the Claimant and for the Registrar of Companies (the Defendant) both consenting to this Order


IT IS ORDERED THAT

pursuant to the above mentioned Act the Company is thereupon to be deemed to  
have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in his official name  
in the "London Gazette"


