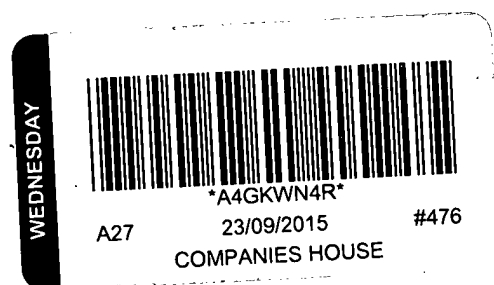


Directors' responsibilities:
