

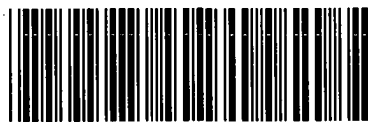

3 Ultimate parent company and related party transactions

The Company is taking advantage of the exemption granted by paragraph 8(j) of FRS 101 Reduced Disclosure Framework, Related Party Disclosures, not to disclose transactions with companies within the William Hill Limited Group who are related parties.

The parent company of the Group preparing consolidated accounts of which the Company is a member is William Hill Limited, a company incorporated in Great Britain.

After Caesars acquired the Group on 22 April 2021, to the balance sheet date of these financial statements the Company's ultimate parent company and ultimate controlling party is Caesars Entertainment Inc., a company incorporated and registered in the United States of America. For the period prior to acquisition and for the 52-week period ended 29 December 2020, the Company's ultimate parent company and ultimate controlling party was William Hill Limited (formerly William Hill PLC), a company incorporated in Great Britain and registered in England and Wales. The parent undertaking of the largest and smallest group, which includes the Company and for which Group accounts are prepared in the UK is William Hill Limited. The Company's immediate parent company and immediate controlling entity is William Hill Organization Limited, a company incorporated in Great Britain.
