



**ORDER**

**UPON THE RESTORED ORDINARY APPLICATION** of the Administrators ("the Administrators") of the companies (each a "Company" and together the "Companies") which are listed in the Schedule to this order and which each intend to call a meeting of members to approve a resolution ("the Resolution") for voluntary winding-up pursuant to Section 84 of the Insolvency Act 1986 ("the 1986 Act")

**AND UPON HEARING** Leading Counsel for the Administrators and Counsel for Federal-Mogul Corporation ("FMC") and the Companies

**AND UPON** the Administrators undertaking by Counsel as soon as reasonably practicable to restore this application and seek the further directions of the court in the event that the Resolution has not been passed in respect of each of the Companies by 4 p m on 20 February 2008

**AND UPON READING** the witness statements of James John Gleave, Andrew Christopher Boydell and Lucinda Ann Mitchell-Fry

**IT IS ORDERED** that

- 1 Pursuant to section 18(3) of the 1986 Act and subject to paragraph 2 below, the administration order applicable to each Company be discharged immediately prior to the passing of the Resolution in respect of that Company
- 2 Pursuant to section 20(1)(b) of the Insolvency Act 1986, the Administrators shall have their release in respect of each Company 14 days after complying with their obligations under Rule 2.52 of the Insolvency Rules 1986 in respect of that Company
- 3 The court file and action number established in respect of each of the Companies' administration proceedings be preserved and continued in operation for the duration of the liquidation applicable to the relevant Company
- 4 In the event that the liquidators for the time being of the Companies intend to seek in relation to Federal-Mogul Sealing Systems (Cardiff) Limited the same (or substantially the same) relief as they intend to seek in relation to all (or substantially all) of the other Companies, the liquidators shall have liberty during the period for which the liquidation of Federal-Mogul Sealing Systems (Cardiff) Limited is continuing
  - (a) to make such applications by way of one composite ordinary application, and
  - (b) to head the said ordinary application in the name of Federal-Mogul Sealing Systems (Cardiff) Limited only, with all other Companies being identified by name and court action number in a schedule to the said ordinary application
- 5 There be permission to apply
