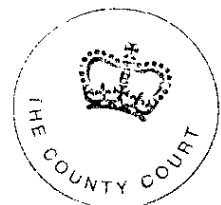

AND upon the Claimant by her solicitors undertaking to:

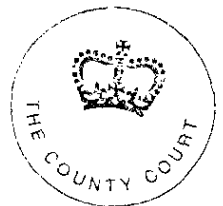


- (A) inform the Registrar of Companies of the title and Court reference





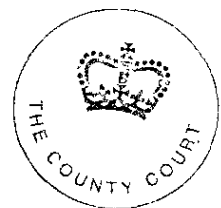
