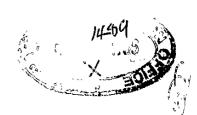

- 1. The Name of the Company is "Kingston Deep Sea LIMITED."
- 2. The Registered Office of the Company will be situate in England.
  - 3. The Objects for which the Company is established are-
- (A) To carry on in all their branches all or any of the businesses of Catching, Storing, Freezing, Salting, Smoking, Curing, Preserving, Processing, Packing, Canning and Manufacturing of Fish or Fish Products, and Buying and Selling or otherwise dealing in Fish or Fish Products of every kind and description, including, Cysters, Lobsters and all other varieties of Shellfish, and the Manufacturing, Processing, Storing and Freezing of Food and Food Products of all kinds
- (B) To carry on all or any of the businesses of Trawler Owners and Managers, Ship Repairers, Ship Chandlers, Grocers and Provision Merchants, Butchers, Oil Refiners, Restaurateurs, Hotel Proprietors, Fish Oultry and Game Dealers, Merchants of all descriptions of Food and Food Products, Carriers on land, sea or air, Railway and Forwarding Agents, Haulage Contractors, Garage Proprietors, Refrigerating Storekeepers, Warehousemen, and Manufactubers of and Dealers in Ice, and Refrigerators; to erect and maintain ice stores,

storage chambers and factories; and to manufacture, purchase, sell, hire, let on hire, repair, and deal in all plant, machinery, tools, implements, vessels, vehicles, gear, tackle, boxes, cases, containers, wrappers, substances, commodities, goods, articles and things likely to be required in connection with

the before-mentioned businesses.

- (c) To carry on any other business which may seem to the Company capable of being conveniently carried on in connection with the above objects, or calculated directly or indirectly to enhance the value of or render more profitable any of the Company's property.
- (D) To purchase or otherwise acquire any freehold or leasehold property, and any real or personal property or rights whatsoever.
- (E) To build, construct, maintain, alter, enlarge, pull down, and remove or replace any buildings.
- (F) To acquire and undertake the whole or any part of the business, goodwill, assets and liabilities of any person, firm, or company, and to acquire an interest in, amalgamate with, or enter into partnership or into any other arrangement with any person, firm, or company.
- (6) To improve, manage, develop, exchange, let on lease or otherwise, mortgage, charge, sell, dispose of, turn to account, grant rights and privileges in respect of, or otherwise deal with all or any part of the property and rights of the Company.
- (H) To invest and deal with the moneys of the Company not immediately required in such shares or upon such securities and in such manner as may from time to time be determined.
  - (1) To lend and advance money or give credit to any persons, firms, or companies, and to give guarantees or become security for any persons, firms, or companies.
  - (J) To borrow or raise money in such manner as the Company shall think fit.

Stog. B.v.E. 1. The regulations contained in Part I of Table A in the First Schedule to The Companies Act, 1948 (such Table being hereinafter called "Table A"), shall apply to the Company save in so far as they are excluded or varied hereby: that is to say, Clauses 24, 33, 75, and 77-in Part I of Table A shall not apply to the Company; and in addition to the remaining Clauses in Part I of Table A, as varied by these Articles, the following shall be the regulations of the Company

LAG.

2. The Company is a Private Company and Clauses 2, 3, 4, 5, and 6 (but not Clause 1) in Part II of Table A shall also apply to the Company.

LAG.

3. The hares shall be under the control of the Directors, who may allot and dispose of or grant options over the same to such persons, on such terms, and in such manner as they think fit.

4. The lien conferred by Clause 11 in Part I of Table A shall attach to fully paid up Shares, and to all Shares registered in the name of any person indebted or under liability to the Company, whether he shall be the sole registered holder thereof or shall be one of two or more joint holders.

Every notice convening a General Meeting shall comply with the provisions of Section 136 (2) of The Companies Act, 1948, as to giving information to Members in regard to their right to appoint proxies; and notices of and other commencations relating to any General Meeting which any Member is entitled to receive shall be sent to the Auditor for the time being of the Company.
