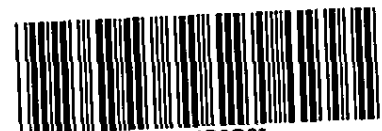
UPON THE APPLICATION of Anthony Michael Robinson creditor of the above

- (B) to inform the Registrar of Companies immediately on the conclusion of the proposed litigation or any appeal therefrom or the conclusion of the claim by any other means


THIS COURT DOTH DECLARE the dissolution of the above named Company to have been void

AND IT IS ORDERED that the Claimant do pay to the Registrar of Companies his costs of the said Application in the agreed sum of £300-00.


