R H Kelly and I were appointed as Joint Liquidators of the Company on 12 June 2012. I write to advise you that the Liquidation has now been concluded

In accordance with Section 94 of the Insolvency Act 1986, a final meeting of members was held on 9 April 2013 The purpose of the meeting was to receive an account of the Joint Liquidators' acts and dealings and of the conduct of the Liquidation (which is contained in this report).

This letter also constitutes our final progress report to members, which was presented to the meeting

We are required to provide certain information about the Company and the Liquidators in accordance with the provisions of the Insolvency Rules 1986. The information can be found in Appendix A of this report. A copy of our receipts and payments account for the period from 12 June 2012 to 9 April 2013 is at Appendix B.

Progress during the period of the report

Assets

The declaration of solvency, made by the directors, showed that the Company's only asset was an inter-company receivable of £10,000 due from The Stanley Works Limited. This asset was distributed in specie to the ordinary shareholder on 4 March 2013. Accordingly, there have been no cash receipts in the Liquidation and there are no further assets to be realised in the Liquidation.

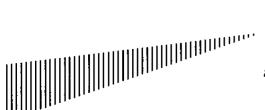
Liabilities

The Company had no known external creditors at the date of liquidation. Notice was advertised in the London Gazette for any persons claiming to be creditors of the Company to submit claims by 31 July 2012, in accordance with Rule 4 182A of the Insolvency Rules 1986. No claims were received

It is customary in a liquidation to seek confirmation from the relevant Crown authorities that they have no claim in respect of corporation tax, VAT, PAYE and National insurance Contributions HM Revenue & Customs have confirmed that they have no claims in this respect and therefore no objection to my concluding the Liquidation

Once our final return and account has been filed at Companies House, we will vacate office and receive our release. Approximately three months after the filing of the final return and account, the Company will be dissolved by the Registrar of Companies.

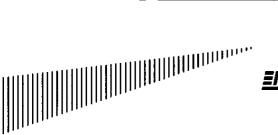

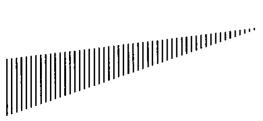
