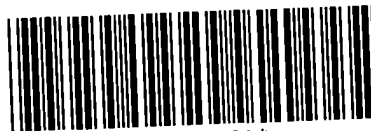


1. The financial statements are prepared in accordance with applicable accounting standards on the historical cost convention.
