Pursuant to Chapter 2 of Part 13 of the Companies Act 2006, the directors of the Company propose that resolution 1 is passed as a special resolution and that resolution 2 is passed as an ordinary resolution (the "**Resolutions**"):

SPECIAL RESOLUTION

1. **THAT** pursuant to section 641(1)(a) of the Companies Act 2006: (i) the share capital of the Company be reduced by cancelling and extinguishing 852,824 of the Company's issued ordinary shares of £1 each registered in the name of ntl South Wales Limited; (ii) the share premium account of the Company be reduced from £947,977 to nil, thereby cancelling and extinguishing the share premium account in full; and (iii) that together the aggregate of such amounts in the sum of £1,800,801 be credited to the profit and loss reserves of the Company.

ORDINARY RESOLUTION

2. **THAT** in accordance with paragraph 42(2)(b) of Schedule 2 to the Companies Act 2006 (Commencement No. 8, Transitional Provisions and Savings) Order 2008, the authorised share capital clause of the Company be and hereby is removed from the articles of association of the Company on and with effect from the passing of this resolution 2.
