Principal activities

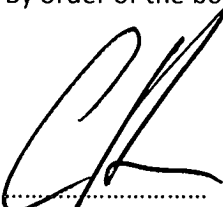

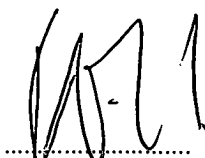

Notes (forming part of the financial statements)

1. Accounting reference date

These financial statements have been prepared for the 52 week period ended on 15 September 2018.

2. Accounting policies

The financial statements have been prepared in accordance with Financial Reporting Standard 101 'Reduced Disclosures Framework' ("FRS 101") and provisions applicable to small companies' regime and the Companies Act 2006.

The company is the sole Trustee of certain pension schemes within the Associated British Foods Group.

3. Transactions

The transactions of the company are carried out on behalf of the pensions schemes of which it is Trustee and accounted for in the accounts of the respective schemes. The company was dormant as defined by section 1169(1) of the Companies Act 2006 throughout the period.

4. Directors' emoluments

The directors have received no emoluments in respect of their services as directors of the company for the current or the previous period.

6. Profit and loss account

During this period and the preceding period the company did not trade and received no income and incurred no expenditure. Consequently, during those periods the company made neither a profit nor a loss. There were no other recognised gains in the period.

7. Holding company

The ultimate holding company is Wittington Investments Limited, which is incorporated in Great Britain and registered in England and Wales.

The largest group in which the results of the company are consolidated is that headed by Wittington Investments Limited. The smallest group in which they are consolidated is that headed by Associated British Foods plc, which is incorporated in Great Britain and registered in England and Wales.
