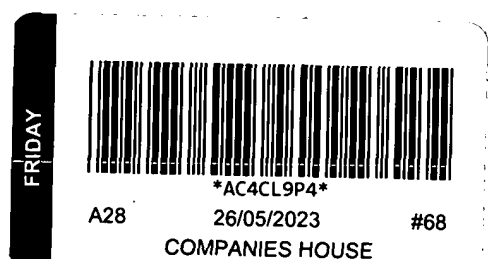

Principal activities



STATEMENT OF DIRECTORS' RESPONSIBILITIES



NOTES (forming part of the financial statements)

1. General information

The company is a private company limited by shares, incorporated in England and Wales and registered with the number 628939. The address of the Company's registered office is Weston Centre, 10 Grosvenor Street, London, W1K 4QY.

2. Accounting reference date

These financial statements have been prepared for the 52-week period ended on 17 September 2022.

3. Accounting policies

The financial statements have been prepared in accordance with Financial Reporting Standard 101 'Reduced Disclosures Framework' ("FRS 101") and the Companies Act 2006.

The company is the sole Trustee of certain pension schemes within the Associated British Foods plc group.

4. Transactions

The transactions of the company are carried out on behalf of the pensions schemes of which it is Trustee and accounted for in the accounts of the respective schemes. The company was dormant as defined by section 1169(1) of the Companies Act 2006 throughout the period.

5. Directors' emoluments

The directors have received no emoluments in respect of their services as directors of the company for the current or the previous period.

The smallest such group of undertakings is headed by Associated British Foods plc, which is incorporated in the United Kingdom and registered in England and Wales.
