

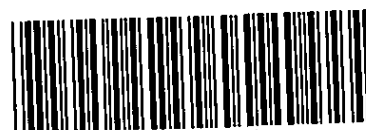
- 1 For the year ended 30 March 2013 the company was entitled to exemption under section 480 of the Companies Act 2006
