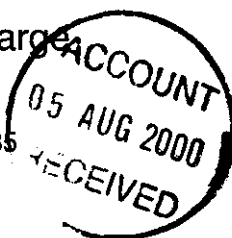



1.
