5 Ultimate parent undertaking

The company's immediate parent undertaking is Harrods Limited, a company incorporated in England and Wales. The ultimate UK parent undertaking of Harrods Limited is Qatar Holding UK Limited (formerly AIT UK Holdings Limited). The largest group of undertakings for which group accounts have been drawn up is that headed by Qatar Holding UK Limited (formerly AIT UK Holdings Limited) and the smallest such group of undertaking, including the company is headed by Harrods Limited. The group accounts will be filed with the Registrar of Companies in due course.

The company is an indirect 100% subsidiary of Qatar Holding LLC which is the strategic investment arm of Qatar Investment Authority, the ultimate controlling party

The company is a wholly owned subsidiary of Qatar Holding UK Limited (formerly AIT UK Holdings Limited) and, as permitted by Financial Reporting Standards 8 'Related Party Disclosures', transactions with other entities in the Qatar Holding UK Group are not disclosed
