How Group Limited ("How"), of which Climate Services Limited is a subsidiary is to enter into a Deed of Guarantee ("the Guarantee") to be made between How and the Midland Bank plc (the "Bank") under which How agrees to pay to the Bank all monies and liabilities whatever due from Tilbury Douglas Plc ("Tilbury") to the Bank. By virtue of the Facilities as defined in Rider 2 and the entering into of the Guarantee by How, the Company may be considered to be giving financial assistance to Tilbury for the purpose of reducing or discharging the liability incurred by Tilbury.

Midland Bank plc ("the Bank"), by a letter dated 3rd September 1998 addressed to inter alia which Climate Services Limited ("the Company") offered certain banking facilities ("the Facilities") to inter alia the Company (the "Offer").
