

INCORPORATION

The Company was incorporated on 9 January 1961.

ACTIVITIES

On 19 May 1987 the Company was appointed to act as Corporate Trustee to the Chartered Accountants Employees Superannuation Scheme (the Scheme). It also holds the title to the Scheme's Bassingthorpe agricultural estate in trust jointly with Chartered Accountants' Trustees Limited.

The Company has no other activities.

DIRECTORS RESPONSIBILITIES

Company law requires the Directors to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the Company and of the result for that period. In preparing these financial statements, the Directors have:

- selected suitable accounting policies and applied them consistently;
- made judgements and estimates that are reasonable and prudent;
- followed applicable accounting standards; and
- prepared the financial statements on the going concern basis.

The Directors are responsible for keeping proper accounting records which disclose on a continuous basis the financial position of the Company and to enable them to ensure that the financial statements comply with the Companies Act 1985. They are also responsible for safeguarding the assets of the Company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

SHAREHOLDINGS

The Institute of Chartered Accountants in England and Wales was the beneficial owner of the whole of the issued share capital of the Company at the beginning and end of the financial year.





We have audited the Financial Statements above.

Respective responsibilities of Directors and Auditors

Basis of opinion


We conducted our audit in accordance with Auditing Standards issued by the Auditing Practices Board. An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures in the financial statements.

It also includes an assessment of the significant estimates and judgments made by the Directors in the preparation of the financial statements, and of whether the accounting policies are appropriate to the company's circumstances, consistently applied and adequately disclosed.
