#### INCORPORATION

The Company was incorporated on 9 January 1961.

#### **ACTIVITIES**

On 19 May 1987 the Company was appointed to act as Trustee of the Chartered Accountants' Employees Superannuation Scheme (the Scheme). The Company has no other activities.
