#### **Acquisition by ALD**

Following the announcement of the proposed acquisition by ALD of the LeasePlan group in January 2022, of which the company is a member, LeasePlan's shareholders and LeasePlan signed a framework agreement with ALD and Societe Generale on 22 April 2022. This framework agreement is a binding agreement, which confirms the terms of the transaction as first disclosed in January 2022 within the Memorandum of Understanding.

#### Ukraine-Russia War

The Ukraine-Russia war is a key contributing factor to the significant increase in energy prices and the wider cost of living crisis affecting the UK and wider Europe. However, the Company's dormant nature means that there is no risk posed to it from customers' potential inability to settle their invoices on the rent as they come due.

#### **AUDITORS**

The company has passed a special resolution not to appoint auditors.

#### **FUTURE DEVELOPMENTS**

Owing to the Company being dormant, the Directors do not expect macro-economic events, such as the Coronavirus Health Crisis and the Ukraine-Russia war, nor the announced acquisition of the LeasePlan group by ALD to have any impact on its financial performance. #### 1. Accounting Policies

The financial statements have been prepared under the historical cost accounting convention in accordance with United Kingdom Generally Accepted Accounting Practice (UK GAAP), including FRS 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland'. The company is dormant, as defined by the Companies Act 2006.

Dial Contracts Limited is a private Company limited by shares incorporated in the United Kingdom under the Companies Act 2006 and is registered in England and Wales. The address of the Company's registered office is shown on page 1.

#### 2. Information Regarding Directors and Employees

The company had no employees during the current and preceding year.

No emoluments were payable to the directors of the company during the current and preceding year.

#### 3. Assets

#### Non-current assets: Investments

The company has two subsidiaries: Dial Vehicle Management Services, of which it owns 99.96% of the shares, and Network Vehicles Limited, in which it has a 99% shareholding. Both investments were fully impaired as at the beginning of the period, owing to the entities being dormant since 1985 and 1994 respectively. All entities have the same ultimate holding company and are consolidated within its accounts, as further elaborated upon within Note 6.

As at 31 December 2021, 100% of LeasePlan Corporation NV's issued and outstanding share capital is owned by a consortium of investors, namely, TDR Capital (United Kingdom), sovereign wealth funds ADIA (United Arab Emirates) and GIC (Singapore), pension funds PGGM (The Netherlands) and ATP (Denmark) and Broad Street Investments (United States). None of these investors has a controlling interest in the Company.

The smallest and largest company in which the financial statements are consolidated is that headed by LeasePlan Corporation NV, the ultimate parent company.
