WRITTEN RESOLUTION

of

WE, the undersigned, being the holders of all the issued Ordinary Shares of £1 each, "A" Ordinary shares of £1 each and Convertible Redeemable Preference shares of 50p each in the capital of the Company entitled to attend and vote at general meetings of the Company, hereby resolve as follows:-

RESOLUTION

THAT, with effect from 1st April, 1992,-

- (i) the Articles of Association of the Company be amended by the deletion of the words "being not less than 28 days after the date of delivery of the notice" from the second paragraph of article 3(B)(4) of the Articles of Association of the Company;
- (ii) the Company shall be authorised to pay an interim dividend of £12.7918 per Ordinary share of £1 each in the capital of the Company equivalent with an associated tax credit to a gross dividend of £17.05576 per share in respect of the Ordinary shares of £1 each in the capital of the Company notwithstanding any other provisions of the Articles of Association of the Company (and in particular, without limitation, articles 3(B)(1), 3(C)(1)(a), 3(C)(c) and regulation 103 of Table A (as defined in the Articles of Association of the Company));
- (iii) the Company shall be authorised to pay an interim dividend of £17.1975 per 'B' Ordinary share of 50p each in issue following the conversion by Wren Investments Limited of 12,840 Convertible Redeemable Preference shares of 50p each into 12,840 'B' Ordinary shares of 50p each, equivalent with an associated tax credit to a gross dividend of £22.93001 per share in respect of the "B" Ordinary shares in the capital of the Company notwithstanding any other provisions of the Articles of Association of the Company (and in particular, without limitation, articles 3(B)(1), 3(C)(1)(a), 3(C)(c) and regulation 103 of Table A (as defined in the Articles of Association of the Company)); and



(iv) the Company shall be authorised notwithstanding the provisions of Article 18 of the Articles of Association of the Company ("the Articles") to have borrowings in excess of £1,850,000 and greater than three-quarters of its Adjusted Capital and Reserves (as defined in the Articles) and the Directors shall not be required to restrict the borrowings of the Company in the manner provided in Article 18 of the Articles.
