#### **1. Accounting policies**

##### **1.1 Basis of preparation of financial statements**

The financial statements have been prepared under the historical cost convention and in accordance with applicable accounting standards

The company is the parent undertaking of a small group and as such is not required by the Companies Act 2006 to prepare group accounts. These financial statements therefore present information about the company as an individual undertaking and not about its group.

The smallest such group is that headed by SITA Holdings UK Limited, a company registered in England & Wales. In the opinion of the director, SITA Holdings UK Limited controls the company as a result of controlling 100% of the issued share capital of Taskmasters Cleansing Services Limited. At the year end GDF Suez SA was the ultimate controlling party, being the ultimate controlling party of SITA Holdings UK Limited
