1 Accounting policies

Basis of preparation

The financial statements have been prepared under the historical cost convention in accordance with applicable UK accounting standards and on a basis consistent with the previous year.

The Company has not traded during the year or the previous year, has incurred no liabilities and, consequently, has made neither profit nor loss. None of the directors received any emoluments in respect of their services to the Company.

Fixed asset investments

Fixed asset investments are stated at historical cost less provision for any diminution in value.

2 Investments held as fixed assets

The Company holds 100% of the issued ordinary share capital of N (Africa) Limited, a company incorporated in England and Wales, which was dormant for the year ended 31 December 2014. The investment is held at cost less any provision for permanent diminution in value. Provision has been made against the full cost of its investment in its subsidiary.
