Chairman's Report

Introduction

- THIS REPORT is made by Ian Wormleighton, licensed Insolvency Practitioner of Deloitte LLP, 4 Brindley 1.1 Place, Birmingham, B1 2HZ (the "Chairman") pursuant to the provisions of sections 4(6) and 4(6A) of the Insolvency Act 1986 (the "Act") and Rule 2.38 of the Insolvency Rules 2016 (the "Rules"). This is the Chairman's Report on the result of the meeting of creditors and the meeting of the member of Travelodge Hotels Limited (the "Company") contemplated by such sections and Rule.
- Any capitalised terms contained in this report not defined herein shall have the same meaning attributed 1.2 to them in the proposal by the Company for a company voluntary arrangement under Part I of the Act issued on 3 June 2020, as modified on 16 June 2020 (the "Proposal").

2 **Decision from Creditors**

- Pursuant to section 3 of the Act, the decision from creditors was taken at a virtual meeting held at 11:00 2.1 a.m. on 19 June 2020.
- The Chairman briefly explained at the meeting of creditors that the legislation which dealt with voluntary 2.2 arrangements was contained in Part I of the Act.
- 2.3 The Chairman advised those present at the meeting that as convenor of the meeting and pursuant to Rule 2.34 he was the Chairman thereof. The Chairman asked whether there was any objection to the notice of meeting and the Proposal, as despatched to creditors and members on 3 June 2020, and modified on 16 June 2020, being taken as read and there was none.
- The Chairman then asked whether any creditor (or any person entitled to do so) present or represented 2.4 at the meeting wished to propose any further modification to the Proposal. None did so.
- The Chairman informed the creditors that a letter clarifying certain matters in relation to the Proposal, 2.5 in particular in relation to the provisions on treatment of Category A Leases, payment of service charge, insurance and Superior Landlord Rent, rent reviews and the payment of interest, and the effect of the exercise of break rights, amongst others, had been prepared by Deloitte LLP and acknowledged by the Company. The main points of the letter dated 17 June 2020 (as amended on 18 June 2020) were outlined to creditors present at the meeting.
- The following resolution (the "Creditors' Resolution") was then proposed: 2.6
 - "That the Proposal for a CVA be approved, in accordance with section 4 Insolvency Act 1986, which includes the appointment of Ian Wormleighton and Daniel Butters as Joint Supervisors of the CVA and that any act be done by one or both of them."
- A vote was then taken on the Creditors' Resolution. Set out in Schedule 1 to this report is a list of the 2.7 creditors (with their respective values) who were present or represented at the meeting, showing how they voted on the Creditors' Resolution.
- It was noted that to become effective, the Proposal must be voted in favour of by 75% or more (in 2.8 value) of those creditors responding. However, the Proposal will not be approved if more than 50% of the total value of the unconnected creditors vote against it. Having regard (inter alia) to the provisions of Rule 15.31 the Chairman declared the Creditors' Resolution passed.
- 2.9 Accordingly, the Proposal was approved by the creditors without further modification apart from the modifications proposed in the letter from Deloitte LLP dated 16 June 2020 and the matters clarified in

the letter prepared by Deloitte LLP of 17 June 2020 (as amended on 18 June 2020) as set out in paragraph 2.5 above.

3 Meeting of the Company

- Pursuant to section 3 of the Act, the meeting of the Company took place by way of virtual meeting at 2:00 p.m. on 19 June 2020.
- The Chairman explained at the meeting of the Company that the legislation which dealt with company voluntary arrangements was contained in Part I of the Act.
- 3.3 The Chairman advised those present at the meeting that as convenor of the meeting and pursuant to Rule 2.34 he was the Chairman thereof. The Chairman asked whether there was any objection to the notice of the meeting and the Proposal, as dispatched to creditors and members on 3 June 2020, and modified on 16 June 2020, being taken as read and there was none.
- 3.4 The Chairman then asked whether the member (or any other person entitled to do so) present or represented at the meeting wished to propose any modification to the Proposal. The member did not do so.
- 3.5 The Chairman informed the member that a letter clarifying certain matters in relation to the Proposal, in particular in relation to the provisions on treatment of Category A Leases, payment of service charge, insurance and Superior Landlord Rent, rent reviews and the payment of interest, and effect of the exercise of break rights, amongst others, had been prepared by Deloitte LLP and acknowledged by the Company on 17 June 2020 (as amended on 18 June 2020).
- 3.6 The following resolution (the "Member's Resolution") was then proposed:

"That the Proposal for a CVA be approved, in accordance with section 4 Insolvency Act 1986, which includes the appointment of Ian Wormleighton and Daniel Butters as Joint Supervisors of the CVA and that any act be done by one or both of them."

- 3.7 A vote was then taken on the Member's Resolution. Set out in Schedule 2 to this report are details of the member who was represented at the meeting and how it voted on the Member's Resolution.
- 3.8 Having regard (inter alia) to the provisions of rule 2.36 the Chairman declared the Member's Resolution passed.
- Accordingly, the Proposal was approved by the member without further modification apart from the modifications proposed in the letter from Deloitte LLP dated 16 June 2020 and the matters clarified in the letter prepared by Deloitte LLP of 17 June 2020 (as amended on 18 June 2020) as set out in paragraph 3.5 above.

4 EC Regulation on Insolvency Proceedings

In the opinion of the Supervisors, the EC Regulation on Insolvency Proceedings applies to the voluntary arrangement and these proceedings are main proceedings as defined by Article 3 of that regulation.
