DRAFT ORDER

UPON THE APPLICATION of the Applicants by Application Notice dated 16 July 2013

AND UPON READING THE DOCUMENTS recorded on the Court file as having been read IT IS ORDERED THAT:

In respect of those administrations, creditors' voluntary liquidations and compulsory liquidations listed in **Schedule 2** to this Order which are the subject of proceedings in County Courts and District Registries in England and Wales and in the courts

outside of England and Wales pursuant to the EC Regulation on Insolvency Proceedings 2000 and the Cross Border Insolvency Regulations 2006 be transferred to the Companies Court, Chancery Division, High Court of Justice, solely for the purpose of making the Order contained in paragraphs 2 to 10 below.

- That each of the Respondents named in Schedule 2A attached to this Order be removed from office as administrator, liquidator (voluntary or compulsory), or supervisor (as the case may be) of the estates listed in the Schedule 2, these removals to take effect 21 days after the making of this Order.
- 3. That each of the Respondents be replaced as such office-holder in the case of each such estate by the Applicants named in Schedule 1 attached to this Order as his/her proposed replacement, these replacements to take effect 21 days after the making of this Order
- 4. Each of the Respondents shall be released from all liability pursuant to the relevant sections of the Insolvency Act 1986 in respect of their acts and omissions and otherwise in respect of their conduct as administrator, liquidator (voluntary or compulsory), or supervisor (as the case may be) of the companies listed as being in administration, creditors' voluntary liquidation, compulsory liquidation or company voluntary arrangement (page 1 of Schedule 2), in the case of each Respondent such release to take effect in relation to each relevant estate 28 days after the date of the report or routine report referred to in paragraph 6 2 of this Order.
- 5 The Applicants shall be entitled to:
- Publish in the London Gazette composite notices relating to all of the resignations and appointments as detailed in Schedule 2 and must do so within 14 days of the coming into effect of parts 2 and 3 of this Order;
- Without incurring any additional expense to any of the said estates, the Applicants shall.
- Notify the Secretary of State as soon as reasonably practicable of the making of this Order, and
- 6 2 Notify the creditors of the making of this Order and provide an explanation of the Order, when the next report or routine report is due to credit of each estate, or earlier if appropriate.

- 7. Service of the said Ordinary Application and this Order on each of the Companies and individuals listed in Schedule 2 appended to this Application herein be dispensed with
- 8. Permission to each creditor and member of each estate to apply to vary or discharge this Order by an application issued within 28 days of receipt of notice directed to be sent out under paragraph 6.2 of this Order
