Directors' report for the year ended 30 June 1994

The directors present their report and the audited accounts for the year ended 30 June 1994.

Principal activities

The company's principal activities are the development and trading in commercial properties.

Review of business

The directors note the progress of the business during the year, and consider the state of affairs at the end of the year and the future prospects of the company to be satisfactory.

Changes in presentation of the accounts

Following the introduction of Financial Reporting Standard No 4, "Capital Instruments", the presentation of the accounts has been amended to conform with the new requirements. Shareholders' funds have been analysed between equity interests and non-equity interests.

Results, dividends and transfers to reserves

The loss on ordinary activities after taxation was £26,000 (1993: £27,000).

The directors do not recommend the payment of a dividend (1993: £357,000) and the loss for the year of £26,000 (1993: £384,000) will be deducted from reserves.

The directors of the company at 30 June 1994, all of whom have been directors for the whole of the year ended on that date, were:
