MEMORANDUM OF ASSOCIATION

- 1. The name of the Company is "The Yehudi Menuhin School Limited."
- 2. The registered office of the Company will be situate in England.
- 3. The objects for which the Company is established are:-
- (1) To establish, provide and carry on in the United

 Kingdom a school or schools where children from any
 part of the world with telents for music may obtain a

 musical and general education of the highest order,
 and generally to foster musical and general education
 of such children
- reasonably necessary for pupils attending and persons employed at any school or schools carried on by the Company, including assembly halls, class rooms, sitting rooms, dermitories, studies, laboratories, libraries music rooms, sanatoria, switching and other baths and gymnasia, and to afford to such pupils and persons facilities and conveniences for religious instruction and reading, writing and exercise of all descriptions, and to provide board lodging are attended as such pupils and persons

- (3) To provide prizes, scholarships and exhibitions for pupils and students whether at any school carried on by the Jommany or at any other school, college or other institution in which education or vocational training is provided
- (4) To make provision or assist in making provision for professorship, readerships, scholarships, exhibitions, bursaries, prizes, salaries and grants for persons engaged in teaching or research connected with or for the advancement of the musical education of children
- (5) To provide for the delivery and holding of lectures exhibitions, public meetings, concerts, dramatic performances, entertainments, classes, conferences and other things reasonably necessary for the advancement of the musical education of children
- (6) To take all such steps as may from time to time be reasonably necessary for the purpose of promoting the objects of the Company or procuring contributions by way of donations, subscriptions, devises, bequests or in any other manner to the funds of the Company

- To establish, subsidice, promote, amalgamate, co-operate or federate with, affiliate or become affiliated to, act as trustee or agent for or manage or lend money or assistance to any association, society, company or other body, whether or not incorporated, whose objects are wholly of a charitable nature, but so that none of the funds of the Company shall be paid to any federated, affiliated or co-operative association, society or other body which does not prohibit the distribution of its income and property ement its members to an extent at least as great as is imposed on the Company by Clause 4 of this Lemorandum of Association
- (8) To found, subsidise, maiago, act as trustee in relation

- to and assist any charitable funds, associations or institutions calculated to promote or accust the Company's objects or any of them
- (9) To solicit and procure by any lawful means and to accept and receive any donation of property of any nature and any devise, legacy or annuity, subscription contribution or fund for the purpose of promoting the Company's objects or any of them, and to apply to such purpose the capital as well as theircome of any such legacy, donation or fund.
 - (10) To undertake, accept, execute and administer, without remuneration, any charitable trusts
 - (11) To establish and support or aid in the establishment and support of any charitable association or institution, trust or fund, and to subscribe or guarantee money for any charitable surpose, which the Company shall consider calculated to promote its objects or any of them
 - (12) To enter into and carry into effect agreements or arrangements with associations, institutions companies or individuals which the Company shall reasonably consider necessary for the attainment or furtherance of its objects or any of them
 - (13) To purchase, take on lease or if exchange, hire or otherwise acquire any real or personal property or any estate or interest whatsoever and any rights privileges and easements over or in respect of any property which may be considered necessary or convenient for the purposes of the Company
 - (14) To sell, manage, lease, mortgage, exchange, dispose of or otherwise deal with and turn to account all or any part of the property of the Company as may reasonably be considered necessary with a view to the promotion of

its objects or any of them

- (15) To borrow and raise money in such manner as may be considered expedient, and to issue debentures, debenture stock and other securities, and for the purpose of securing any debt or other obligation of the Company to mortgage or charge all or any part of the property of the Company
 - (16) To invest and deal with any moneys of the Company not immediately required for use in connection with any of its objects in the purchase of, or at interest upon the security of, such stocks, funds, shares, securities, units in a unit trust or other investments or property moveable or immoveable or of whatsoever nature, and situated anywhere in the world, and whether involving liability or not, and whether in possession or reversion
 - other Acts or authorisations for the purpose of enabling the Company to carry any of its objects into effect or of effecting any modifications of the Company's constitution provided however that no modification shall be made to the Company's constitution by which its objects would cease to be exclusively charitable or for any other purpose which may be considered expedient and to oppose any proceedings or actions which may be considered calculated directly or indirectly to prejudice the Company's interests.
 - (18) To procure the registration or incorroration of the Company in or under the laws of any place outside England, and to procure any Act of Parliament, provisional order, enactment, decree or other legislative or executive act of any government, state colony, province, dominion, sovereign or authority supreme, municipal, local or otherwise for the purpose of enabling the Company to carry any of its objects

Provided also that in case the Company shall take or hold any property subject to the jurisdiction of the Charity Commissioners for England and Wales or of the Secretary of State for Education and Science the Company shall not sell, mortgage, charge or lease the same without such authority approval or consent as may be required by law, and as regards any such property the Council or other the managers or trustees of the Company shall be chargeable for such property as may come into their hands, and shall be answerable and accountable for their own acts, reseipts, neglects and defaults and for the due administration of such property in the same manner and to the same extent as they would have been answerable and accoutable as such Council or other man ers or trustees if no incorporation had been effected, and the incorporation of the Company shall not diminish or impair any control or authority exercisable by the Chancery Division of the High Court of Justice, the Charity Commissioners or the Secretary of State for Education and Science over such Council or other managers or trustees, but as regards any such property they shall be subject, jointly and separately, to such control or authority as if the Company were not incorporated. the Company shall take or hold any property which may be subject to any trusts the Company shall only deal with the same in 4. The income and property of the Company, whencesoever derived, shall be applied solely towards the promotion of the objects of the Company as set forth in this Memorandum of Association and no portion thereof shall be paid or transferred directly or indirectly by way of dividend, bonus or otherwise howsoever by way of profit to the Members of the Company

Provided that nothing herein contained shall prevent the payment in good faith of reasonable and proper remuneration to any officer or servant of the Compony, or to any Member of the Company, for any services actually rendered to the Company, or the payment of interest at a rate not exceeding five per cent. per annum on money lent or reasonable and proper rent for premises demised or let by any Member to the Company, but so that no Hember of the Council or other governing bod; for the time being of the Company shall be appointed to any salaried office of the Company or to any office of the Company paid by fees, and no remuneration or other benefit in money or money's worth shall be given by the Company to any member of such Council or other governing body except repayment of out-of-pocket expenses and payment of interest at the rate aforesaid on money lent or of reasonable and proper rent for premises demised or let to the Company; provided that the provision last aforesaid shall not apply to any payment to any railway, gas, electric lighting, water, cable or telephone company of which a member of the Council or other governing body may be a member or to any other company in which such member shall not hold more than one-hundredth part of the capital, and such member shall not be bound to account for any share of profits which he may receive in respect of eny such payment

In Writing

Written or produced by any substitute for writing, or partly written and partly so produced.

Words importing the singular number only shall include the plural number and vice versa.

Words importing the masculine gender shall include the feminine gender.

Words importing persons shall include corporations.

The expression "Secretary" shall include an assistant or deputy Secretary and any person appointed by the Council to perform any of the duties of the Secretary.

Save as aforesaid, any words or expressions defined in the Act, if not inconsistent with the subject or context, shall bear the same meanings in these presents.

Reference herein to any provision of the Act shall be a reference to such provision as modified by any statute for the time being in force.

BUSINESS

- 2. The Company is established for the purposes expressed in its Memorandum of Association.
- 3. Any branch or kind of business which the Company is either expressly or by implication authorised to undertake may be undertaken by the Council at such time or times as it may consider expedient and further may be suffered by it to be in abeyance, whether such branch or kind of business may have been actually commenced or not, so long as the Council may consider it expedient not to commence or proceed with the same.
- 4. Subject to the provisions (so far as applicable) of the Act the business of the Company may be commenced so soon after the incorporation of the Company as the Council shall think lit.
- 5. The Office shall be at such place in England as the

Council shall from time to time appoint.

MEMBERS

- 6. The subscribers to the Memorandum of Association and such other persons as shall be admitted to membership in accordance with these presents, and none others, shall be Managers of the Company and shall be entered in the Register of Members accordingly.
- 7. For the purposes of registration of the Company the number of Members of the Company is to be taken to be unlimited.
- 8. There shall be two classes of Members of the Company, namely:-
 - (1) Ordinary Members.
 - (2) Honorary Members.
- 9. The Ordinary Members shall be the subscribers to the Memorandum of Association and all persons subsequently admitted by the Council to membership as Ordinary Members.

 10. No person shall be admitted to membership of the Company as an Ordinary Member unless:
 - (1) he has signed and sent to the Secretary an application for admission framed in such terms as the Council shall from time to time prescribe, and
- (2) he has been elected to membership by the Council.

 11. The decision of the Council as to whether or not any applicant for admission to membership of the Company shall be admitted shall be final and conclusive, and the Council shall be entitled in its absolute discretion to refuse 30 admit to membership any applicant without giving any reason for such refusal.
- 12. The Honorary Members shall be such persons as the Council may from time to time admit to honorary membership of the Company with their consent in writing. Every Honorary Member shall continue to be a Member for life or

for such shorter period as the Council at or after the time of his admission may determine.

- 13. Every Hember shall use his bost andeavours to promote the objects and interests of the Company and shall observe all the Company's regulations affecting him contained in or effective pursuant to these presents.
- 14. The rights of every Member shall be personal to himself and shall not be transferable, transmissible or chargeable by his own act, by operation of law or otherwise.

 15. A Member shall immediately cease to be a Member upon the happening of any one of the events following, namely:-
 - (1) If he shall resign membership by writing under his hand left at the Office.
 - (2) If the Member, being an individual, shall die or become lunatic or bankrupt or compound with his creditors or, being a corporation, shall go into liquidation or have a receiver appointed of its undertaking and assets or any part thereof.
 - (3) If he shall fail to perform any obligation binding upon him under these presents for one month after notice in writing requiring him to do so shall
 - the opinion of the Council his conduct shall be calculated in any respect to be prejudicial to the interests of the Company and he shall fail to remely such conduct to the satisfaction of the Council for one month after notice in writing requiring him to do so shall have been served upon him by the Company and if also in either of such cases the Council by resolution passed by a majority of not less than three-fourths of the members of the Council present at a meeting of the Council of which notice specifying the

 GENERAL MEETINGS.
 - calendar year as its Arnual General Meeting in every calendar year as its Arnual General Meeting at such time and place as may be determined by the Council, and shall specify the Meeting as such in the notices calling it, provided that every Annual General Meeting except the first shall be held not wore than fifteen months after the holding of the last preceding Annual General Meeting, and that so long as the Company holds its first Annual General Meeting within eighteen months after its incorporation it need not hold it in the year of its incorporation or in the following year.
 - 19. All General Meetings, other than Annual General Meetings, shall be called Extraordinary General Meetings.
 20. The Council may whenever it may think fit convene an Extraordinary General Meeting, and Extraordinary General Meetings, and Extraordinary General Meetings shall also be convened on such requisition or in default may be convened by such requisitionists, as provided by Section 132 of the Act.
 - 21. Twenty-one days' notice in writing at the least of every Annual General Meeting and of every Meeting convened to pass a Special Resolution, and fourteen days' notice in writing at the least of every other General Meeting (exclusive in every case both of the

· day on which it is served or deemed to be served and of the day for which it is given), specifying the place, the day and the hour of the Meeting, and in the case of special business the general nature of that business, shall be given in the manner hereinafter mentioned to such persons (including the Auditors) as are under these presents or under the Act entitled to receive such notices from the Company; but with the consent of all the Members having the right to attend and vote thereat, or of such proportion of them as is prescribed by the Act in the case of Meetings other than Annual General Meetings, a Meeting may be convened by such notice as those Members may think fit The accidental omission to give notice of a Meeting to, or the non-receipt of such notice by, any person entitled to receive notice thereof shall not invalidate any resolution passed, or proceeding had, at any Meeting

PROCEEDINGS AT GENERAL MEETINGS

- 23. All business shall be deemed special which is transacted at an Extraordinary General Meeting and also all business which is transacted at an Annual General Meeting with the exception of the consideration of the Accounts and Balance Sheet and the Reports of the Council and Auditors and the election of the Auditors and the fixing of their remuneration.
 - 24. No business shall be transacted at any General Meeting unless a quorum be present when the Meeting proceeds to business. Three Ordinary Members present in person shall form a quorum.
 - 25. If within half an hour from the time appointed for holding any General Meeting a quorum be not present the Meeting, if convened on the requisition of Members, shall be dissolved. In any other case the

three Members present in person or by proxy.

Unless a poll be so demanded a declaration by the

Chairman that a resolution has been carried, or

carried unanimously, or by a particular majority, or

lost, and an entry to that effect in the Minute Book

of the Company, if purporting to be signed by such

Chairman or by the Chairman of the next succeeding

Meeting, shall be conclusive evidence of the fact without

proof of the number or proportion of the votes recorded

in favour of or against such resolution.

- 29. If a poll be duly demanded it shall be taken in such manner as the Chairman shall direct, and the result of the poll shall be deemed to be the resolution of the Meeting at which the poll was demanded.
- 30. In case of an equality of votes, whether on a show of hands or on a poll, the Chairman of the Meeting at which the show of hards takes place or at which the poll is demanded shall be entitled to a second or casting vote.
- 31. A poll demanded on the election of a Chairman or on a question of adjournment shall be taken forthwith. A poll demanded on any other question shall be taken at such time and place as the Chairman shall direct
- 32. The demand for a poll shall not prevent the continuance of a Meeting for the transaction of any business other than the question on which the poll has been demanded.

VOTES OF MEMBERS

33. On a show of hands every Ordinary Member present in person shall have one vote, and on a poll every Ordinary Member present in person or by proxy shall have one vote. Honorary Members shall be entitled to

attend but not to vote at any Meeting.

- 34. At any General Meeting a corporation being an Ordinary Member may vote by any proxy or duly authorised representative. Who shall be entitled to speak, demand a poll, vote, act as proxy and in all other respects exercise the rights of an Ordinary Member and shall be reckoned as an Ordinary Member for all purposes.
- 35. No objection shall be raised to the qualification of any voter except at the Meeting or adjourned Meeting at which the vote objected to is given or tendered, and every vote not disallowed at such Meeting shall be valid for all purposes. Any such objection made in due time shall be referred to the Chairman of the Meeting, whose decision shall be final and conclusive.
 - 36. On a poll votes may be given either personally or by proxy.
 - 37. The instrument appointing a proxy shall be in writing under the hand of the appointor or of his attorney duly authorised in writing or, if the appointor be a corporation, either under its common seal or under the hand of an officer or attorney so authorised.
 - 38. No person shall act as proxy unless (1) he is entitled on his own behalf to be present and vote at the Meeting at which he acts as proxy or (2) his appointment be approved by the Council, or (3) he be appointed to act at that Meeting either as a representative of a corporation pursuant to Section 139 of the Act or as its proxy.
 - 39. The instrument appointing a proxy and the power of attorney or other authority (if any) under which it is signed, or a notarially certified copy of such power or authority, shall be deposited at the Office not less than forty-eight hours before the time appointed for holding the Meeting or adjourned Meeting at which

THE COUNCIL

- Subject and without prejudice to Article 43, the power to appoint and (in the manner mentioned in Article 49 (5)) remove Governors shall be vested in the Council, but so that the total number of Governors shall not at any time exceed the maximum number fixed by or in accordance with these presents.
 - Every Governor shall hold office until he shall die 45. or shall cease to hold office by virtue of Article 49.

DISQUALIFICATION OF GOVERNORS

- 49. The office of a Governor shall be vacated in any one of the events following namely:-
 - (1) If he shall resign his office by writing under his hand left at the Office.
 - (2) If he shall become lunatic or of unsound mine or bankrupt or compound with his creditors.
 - (3) If he shall hold any place of profit under the Company.
 - (4) If he shall become prohibited from being a Governor by reason of any order made under the Act.
 - (5) If he shall be removed from office by resolution passed by the affirmative vote of not less than three-fourths of the Governors present at the Meeting of the Council at which the resolution was proposed.

of business, adjourn and otherwise regulate its meetings as it shall think fit. Unless and until otherwise determined by the Council questions arising at any meeting shall be determined by a majority of votes. In case of an equality of votes the Chairman shall have a second or casting vote.  - 52. The Council shall appoint from among its members a Chairman and a Vice-Chairman, and in the event of My vacancy in either of those offices the Council shall so soon as practicable fill the vacancy. The quorum necessary for the transaction of the business of the Council may be fixed by the Council and unless and until so fixed shall be two.

54, No publitabe tion matrological art offere in Article 51 shall be transacted at any meeting of the Council unless in the opinion of the Chairman of the meeting supported by a majority of the other Governors present at the meeting such business arises directly out of an item included in the agenda or out of the minutes of the last preceding meeting or is a matter of urgency. If at any meeting of the Council neither the 55。 Chairman nor the Vice-Chairman be present within fifteen minutes after the time appointed for holding the meeting the Governors present shall choose one of their number to be Chairman of the meeting. A resolution in writing signed by all the Governors for the time being in the United Kingdom shall be as effective as if it had been passed at a meeting of the Council duly convened and held. The Council may delegate any of its powers (other than the power to admit or expel Members of the Company) 57. to Committees, as it may think fit. In the exercise of the powers so delegated any Committee so formed shall conform to any regulations which may be imposed on it A Committee may elect a Chairman of its meetings; by the Council. if no such Chairman be elected, or if at any meeting the Chairman be not present within fifteen minutes after the time appointed for holding the same, the members of the Committee present shall choose one of their number to be Chairman of the meeting. 59. A Committee may meet and adjourn as it shall think proper. All acts bona fide done at any Council or Committee meeting or by any person acting as a Governor, notwithstanding that it be afterwards discovered that there was some defect in the appointment of any Governor or person acting as aforesaid or that he or any of them was ineligible or had vacated office, shall be as valid as if every such person had been duly appointed and was eligible and had continued to be a Governor.

POWERS AND DUTIES OF THE COUNCIL.

The business and affairs of the Company shall be 61. managed by the Council, which may pay all expenses incurred in promoting and registering the Company and (subject as hereinafter provided) may exercise all such powers of the Company as are not by the Act or by these presents required to be exercised by the Company in General Meeting, subject nevertheless to any regulations of these presents, to the provisions of the Act and to such regulations, being not inconsistent with the aforesaid regulations or provisions, as may be prescribed by the Company in General Meeting; but no regulation made by the Company in General Meeting shall invalidate any prior act of the Council which would have been valid if such regulation had not been made. The general powers given by this Article shall not be limited or restricted by any special authority or power given to the Council by any other Article.

All cheques, promissory notes, drafts, bills of exchange and other negotiable or transferable instruments, and all receipts for moneys paid to the Company shall be signed, drawn, accepted, endorsed or otherwise executed, as the case may be, in such manner as the Council shall from time to time by resolution determine.

SECRETARY

The Secretary shall be appointed by the Council 64. for such time, at such remuneration and upon such conditions as it may think fit, and any Secretary so appointed may be removed by the Council. The provisions of Sections 177 to 179 of the Act shall apply and be observed. The Council may from time to time appoint an assistant or deputy Secretary, and any person so appointed may act in place of the Secretary if there be no Secretary or no Secretary capable of acting.

MINUTES

- The Council shall cause minutes to be made in books provided for the purpose:-
 - (1) of all appointments of officers made by the Council, and
 - of the names of the Governors present at every meeting of the Council and of any Committee of (2) the Council, and
 - (3) of all resolutions and proceedings at all meetings of the Company of the Council and of all Committees of the Council.

Any such minutes of any meeting, if purporting to he signed by the Chairman of such meeting, or by the

THE SEAL

The Seal shall not be affixed to any instrument 66. except by the authority of a resolution of the Council and shall be so affixed in the presence of at least one Governor and of the Secretary or such other person as the Council may from time to time appoint for the purpose, and such Governor and Secretary or other person aforesaid shall sign every instrument to which the Seal is so affixed in their presence, and in favour of any purchaser or person bona fide dealing with the Company such signatures shall be conclusive evidence of the fact that the Seal has been properly affixed.

ACCOUNTS

- The Council shall cause true accounts to be kept 67。 with respect to:-
 - (1) all sums of money received and expended by the Company and the matters in respect of which such receipt and expenditure take place;
 - (2) all sales and purchases of goods by the Company;
 - (3) the assets and liabilities of the Company
 - Proper books shall not be deemed to be kept if there are not kept such books of account as are necessary to give a true and fair view of the state of the affairs of the Company and to explain its transactions The books of account shall be kept at the Office, or, subject to Section 147 (3) of the Act, at such other place or places as the Council may think fit, and shall always be open to the inspection of the Governors. Subject and without prejudice to the provisions of Article 68 as regards Governors, the Company in General

reasonable conditions and regulations as to the time and manner of inspection by Members of the accounts of the Company, and subject to any such conditions and regulations such accounts shall be open to the inspection of Members at all reasonable times during business hours.

- 70. At the Annual General Meeting in every year the Council shall lay before the Company a proper income and expenditure account for the period since the last preceding account (or in the case of the first account since the incorporation of the Company) made up to a date not more than four months before such meeting and a balance sheet made up as at the same date containing all such particulars with regard to the capital, the assets and the liabilities of the Company as are required by the Act.
 - 71. Every such balance sheet as aforesaid shall be signed on behalf of the Council by two Governors and shall be accompanied by a report of the Council as to the state of the Company's affairs, and it shall also have attached to it the Auditors' report.
 - 72. A copy of every income and expenditure account, balance sheet and report and of any other documents required by law to be annexed or attached thereto or to accompany the same shall not less than twenty-one clear days before the date of the Annual General Meeting, subject nevertheless to the provisions of Section 158 (1) (c) of the Act, be sent to the Auditors and to all other persons entitled to receive notices of General Meetings in the manner in which notices are hereinafter directed to be served. The Auditors' report shall also be open to inspection and be read before the Meeting as required by Section

AUDIT

73. Auditors shall be appointed and their duties regulated in accordance with Sections 159 to 162 of the Act, the Governors being treated as the Directors mentioned in those Sections.

NOTICES

- 74. Any notice or other document may be served by the Company on any Member either personally or by sending the same through the post in a prepaid envelope addressed to such Member at his registered address as appearing in the Register of Members.
- 75. Any notice or other document, if served by post, shall be deemed to have been served on the day following that on which the envelope containing the same is put into the post, and in proving such service it shall be sufficient to prove that such envelop: was properly addressed, stamped and possed.
 - 76. Any notice or other document which pursuant to these presents is required to be served by any Member on the Company or on the Secretary or any other officer of the Company may be served by leaving the same at the Office or by sending the same through the post in a prepaid envelope addressed to the Company or to the Secretary or other officer of the Company, as the case may be, at the Office.

WINDING UP

77. If the Company shall be wound up the provisions contained in Clause 7 of the Memorandum of Association shall be performed and have effect in all respects as

if the same were repeated in these presents.

INDEMNITY

78. Every Governor, officer and Auditor of the Company shall be indemnified out of the assets of the Company against any liability incurred by him as such Governor, officer or Auditor in defending any proceedings, whether civil or criminal, in which judgment is given in his favour or in which he is acquitted or in connection with any application under Section 448 of the Act in which relief is granted to him by the Court.
