IT IS ORDERED THAT:

 In respect of those Administrations, Bankruptcles, Compulsory Liquidations, Creditors' Voluntary Liquidations, Individual Voluntary Arrangements and Members' Voluntary Liquidations Identified in the schedule attached to this Application Notice (the "Schedule") as being the subject of proceedings in the various County Courts specified in the column headed "Court" in the Schedule, those proceedings be transferred to the High Court Division, solely for the purpose of making the Orders contained in the paragraphs below and thereafter be transferred back to the relevant County Court.

- 2. The following removals and appointments take place with immediate effect:
 - 2.1. In relation to the Administration appointment held solely by the First Respondent, the First Respondent be removed from office and the Second and Third Respondents be appointed as joint Office Holders in the First Respondent's place as proposed and identified in the Schedule. The Second and Third Respondents are to act jointly and severally. In relation to the Administration appointments held jointly by the First Respondent and the Second Respondent, the First Respondent be removed from office and the Third Respondent be appointed in the First Respondent's place as proposed and identified in the Schedule. The Second and Third Respondents are to act jointly and severally. In relation to the Administration appointment held jointly by the First and Second Respondent and the Fourth Respondent, the First Respondent be removed from office as proposed and identified in the Schedule.
- 2.2. In relation to the Bankruptcy appointments held jointly by the First Respondent and the Second Respondent, the First Respondent be removed from office and the Third Respondent be appointed in the First Respondent's place as proposed and identified in the Schedule. The Second and Third Respondents are to act jointly and severally. In relation to the Bankruptcy appointment held jointly by the First and Third Respondent, the First Respondent be removed from office and the Second Respondent be appointed in the First Respondent's place as proposed and identified in the Schedule. The Second and Third Respondents are to act jointly and severally.
- 2.3. In relation to the Compulsory Liquidation appointments held jointly by the First Respondent and the Second Respondent, the First Respondent be removed from office and the Third Respondent or Fifth Respondent be appointed in the First Respondent's place as proposed and identified in the Schedule. The Second and Third Respondents and the Second and Fifth Respondents are to act jointly and severally.

- In relation to the Creditors' Voluntary Liquidation appointments held solely by 2.4. the First Respondent, the First Respondent be removed from office and the Second and Third Respondent be appointed as joint Office Holder in the First Respondent's place as proposed and identified in the Schedule. In relation to the Creditors' Voluntary Liquidation appointments held jointly by the First Respondent and the Second Respondent, the First Respondent be removed from office and the Third Respondent or Fifth Respondent be appointed in the First Respondent's place as proposed and identified in the Schedule. The Second and Third Respondents and the Second and Fifth Respondents are to act jointly and severally. In relation to the Creditors' Voluntary Liquidation appointments held jointly by the First Respondent and the Third Respondent, the First Respondent be removed from office and the Second Respondent be appointed in the First Respondent's place as proposed and identified in the Schedule. The Second and Third Respondents are to act jointly and severally.
- 2.5. In relation to all Individual Voluntary Arrangement ("IVA") appointments held jointly by the First Respondent and the Second Respondent, the First Respondent be removed from office and the Third Respondent be appointed in the First Respondent's place place as proposed and identified in the Schedule. The Second and Third Respondents are to act jointly and severally.
- 2.6. In relation to the Members' Voluntary Liquidation appointments held jointly by the First Respondent and the Second Respondent, the First Respondent be removed from office and the Third Respondent be appointed in the First Respondent's place as proposed and identified in the Schedule. The Second and Third Respondents are to act jointly and severally. In relation to the Members' Voluntary Liquidation appointments held jointly by the First Respondent and the Third Respondent, the First Respondent be removed from office and the Second Respondent be appointed in the First Respondent's place as proposed and identified in the Schedule. The Second and Third Respondents are to act jointly and severally.
- 2.7. The effect of the Orders is as summarised by reference to the outgoing and replacement office holders as set out in the columns headed "Current Lead IP" and "Current Joint IP" and "New Lead IP" and "New Joint IP" in the Schedule.
- 3. The Applicant shall within 28 days of the date of the Order publish in the Gazette one composite notice relating to all new appointments effected hereby and shall file any

appropriate notices in respect of the First Respondent's resignation and those appointments with the Registrar of Companies and the Department for Business, Innovation and Skills (Insolvency Service) as appropriate.

- 4. The First Respondent shall be granted his release as appropriate 21 days after the publication in the Gazette referred to above.
- 5. Pursuant to rules 2.47(3) and 2.47(3A) of the Insolvency Rules 1986 (the "Rules"), the time for the filing of the progress report in the Administration of the companies listed in the Schedule attached hereto be extended to the date of the next scheduled report in each case.
- 6. Pursuant to Rule 6.78A (7) of the Rules, the time for the filling of the progress report in the Bankruptcles of the individuals listed in the Schedule attached hereto be extended to the date of the next scheduled report in each case.
- 7. Pursuant to Rule 4.49B of the Rules, the time for the filing of the progress report in the Compulsory Liquidations of the companies listed in the Schedule attached hereto be extended to the date of the next scheduled report in each case.
- 8. Pursuant to Rule 4.49C-CVL of the Rules, the time for the filing of the progress report in the Creditors' Voluntary Liquidations of the companies listed in the Schedule attached hereto be extended to the date of the next scheduled report in each case.
- 9. Pursuant to Rule 5.31A of the Rules, the time for the filling of the progress report in the Individual Voluntary Arrangements of the Individuals listed in the Schedule attached hereto be extended to the date of the next scheduled report in each case.
- 10. Pursuant to Rule 4.49C-CVL of the Rules, the time for the filing of the progress report in the Members' Voluntary Liquidations of the companies listed in the Schedule attached hereto be extended to the date of the next scheduled report in each case.
- 11. The Applicant shall, when the next routine report is due to the creditors/members of each Administration, Bankruptcy, Compulsory Liquidation, Creditors' Voluntary Liquidation, Individual Voluntary Arrangement and Members' Voluntary Liquidation, give written notice of the making of the Order to each such creditor/member, such notice to include the following matters:
 - 11.1. An explanation as to the effect of the Order.
 - 11.2. Express reference to the liberty to apply as set out in the Order.

- 11.3. In the case of the Individual Voluntary Arrangements and the Administrations, the provision of such information as might reasonably be required with regard to the conduct of the Individual Voluntary Arrangements and the Administrations (as the case may be).
- 11.4. In the case of the Compulsory liquidations and Creditors' Voluntary Liquidations, Individual Voluntary Arrangements and Bankruptcies where liquidation or creditors' committees have been appointed, an explanation that (to the extent that any information which would otherwise be required to be provided under rule 4.108(3) or 6.126(2) of the Rules has not already been provided as part of that report) it is open to the committee to require the Applicant and the Respondents appointed or remaining in office to provide an account of the administration of the estate, including:
 - 11.4.1. A summary of receipts and payments.
 - 11.4.2. A statement that he has reconciled his accounts.
- 11.5. In the case of the Compulsory liquidations and Creditors' Voluntary Liquidations, Individual Voluntary Arrangements and Bankruptcies where no liquidation or creditors' committees have been appointed, an explanation that, to the extent that such information has not already been provided as part of the routine report, it is open to any creditor to apply for an Order that the Applicant do provide such information as might otherwise be required by rule 4.108(3) or 6.126(2) of the Rules (as the case may be), that is to say an account of the administration of the estate including:
 - 11.5.1. A summary of receipts and payments.
 - 11.5.2. A statement that he has reconciled his accounts.
- 11.6. In the case of the Members' Voluntary Liquidations, an explanation that, to the extent that any information which might otherwise be required to be supplied under rule 4.142(2) of the Rules has not already been provided as part of the routine report, it is open to any member to apply to Court for an Order that the Applicant do provide such information, that is to say an account of the administration of the estate, including:
 - 11.6.1. A summary of receipts and payments.
 - 11.6.2. A statement that he has reconciled his accounts.

- 11.7. Notification that if the Applicant In question has been required to provide the information referred to in paragraphs 11.4 to 11.6 above, whether by the liquidation/creditors' committee or by Court Order on the application of any Individual creditor, the Applicant's costs of complying with such request or Order shall, unless good reasons to the contrary are demonstrated, be paid as a cost of the Administration, Bankruptcy, Compulsory Liquidation, Creditors' Voluntary Liquidation, Individual Voluntary Arrangement or Members' Voluntary Liquidation as the case may be.
- 12. Liberty to each creditor/member of each Administration, Bankruptcy, Compulsory Liquidation, Creditors' Voluntary Liquidation, Individual Voluntary Arrangement or Members' Voluntary Liquidation to apply to vary or discharge the Order within 28 days of receipt of the notices directed to be sent under paragraph 11 above.
- 13. The costs of the Application in so far as attributable to an Individual insolvency should be fixed and paid in the ordinary way as remuneration costs and expenses of such insolvency. Costs which cannot be attributed to an individual insolvency proceeding should be apportioned equally between the insolvencies in the Schedule so long as the costs apportioned to each individual estate shall not exceed 10% of the assets realised in the particular insolvency or voluntary arrangement.
- 14. Compliance with rule 7.10D(3) of the Rules is varied so that the lodging of a certified copy of the Order, once sealed, with each Court is deemed to be compliant with that Rule.

15. Service of Notice of the Application upon the Respondents be dispensed with.
