RIDER B

That part of the Share capital of the Target not owned by the Purchaser or certain members of the Folkes family and/or certain Folkes family trusts.

RIDER C

The assistance will take the form of:

- (i) the Subsidiary entering into a joint and several composite guarantee (the "Guarantee") in favour of the Bank; and
- (ii) the Subsidiary (as lender) entering into an intra-group loan agreement (the "Intra Group Loan Agreement") with the Purchaser (as borrower).

RIDER D

The principal terms on which the assistance will be given are:-

- (i) under the terms of the Guarantee, the Subsidiary shall provide to the Bank a joint and several composite guarantee, guaranteeing all obligations and liabilities of, amongst others, the Purchaser, which obligations include, but are not limited to, obligations incurred in respect of and for the purpose of the Acquisition, in favour of the Bank; and
- (ii) under the terms of the Intra Group Loan Agreement, the Subsidiary, amongst others, shall enter into a non-interest bearing intra group loan agreement with the Purchaser. Moneys advanced to the Purchaser pursuant to the Intra Group Loan Agreement shall be applied *inter alia* for the purpose of making payments in respect of obligations incurred by the Purchaser under the Facilities Agreement which obligations include, but are not limited to, obligations incurred by the Purchaser in respect of and for the purpose of the Acquisition and for other such purposes as may be agreed from time to time by the parties.

RIDER E

The amount of cash to be transferred to the person assisted is up to the maximum aggregate amount of cash made available from time to time by the Subsidiary under the Intra-Group Loan Agreement.

RIDER F

The same date as that upon which this declaration is made or a date within 8 weeks of the date hereof.
