- (7) the hearing fixed for the 14th June 2018 at 2:00 pm be vacated



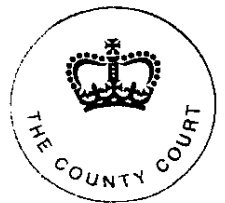


