

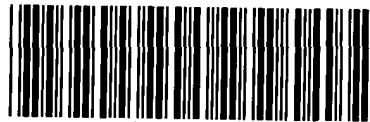

1. Accounting policies

1.1. Accounting convention

The accounts are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

1.2. Turnover

Turnover represents the total amount receivable from the rent of land.

1.3. Tangible fixed assets and depreciation

Depreciation is provided at rates calculated to write off the cost less residual value of each asset over its expected useful life, as follows:

Tractor	-	20% Straight line
Cattleshed	-	5% Straight line
Dutch Barn	-	5% straight line
Implements	-	10% to 15% Straight line

3. Fixed asset investments

As part of the arrangement for ending the milk marketing scheme, provision was made for the transfer of certain assets from the Milk Marketing Board to Milk Marque Limited

As a result of these arrangements the company now owns:

1) 368 ordinary shares of 10p each in Genus Plc. At 30 September 2015 their quoted market value on the London Stock Exchange was £6,809 (2014 - £4,294)

2) 1,119 ordinary shares of 25p each in Dairy Crest Group Plc. At 30 September 2015 their quoted market value on the London Stock Exchange was £5,226 (2014 - £4,158)
