



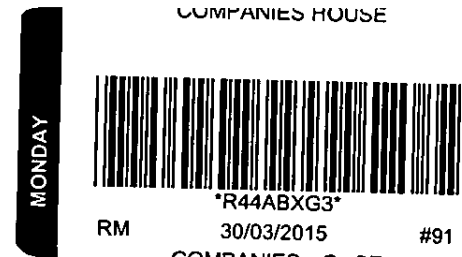

We, the undersigned, each being a Member of the School entitled to vote on the Circulation Date, pass the following special resolution and ordinary resolutions as written resolutions to have effect as if passed by the School in general meeting pursuant to Section 288 of the Companies Act 2006

Special Resolution

- (1) The Articles of Association of the School are amended as follows
- a) Article 5 4 is deleted in its entirety and replaced with *"It is the intention that up to seven members of the Governing Body shall be the parents of children who are for the time being pupils of the School. At least half of such parent Governors shall be persons not permanently resident in Greece (for example, expatriates or persons residing outside Greece), of whom at least half shall be British citizens. The remaining parent Governors may or may not be permanently resident in Greece. In any event, the number of parent Governors may not be higher than, or equal to, the number of non-parent Governors. Should at any time, the number of parent Governors become higher than, or equal to, the non-parent Governors, then the Chairman's Committee will be given a maximum of 6 months to correct the imbalance, so as not to disrupt the effective operation of the Governing Body"*
