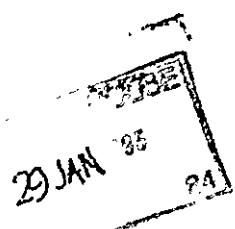

DIRECTORS' REPORT

The directors submit their annual report and the audited accounts for the year ended 31 March 1992.

Principal activities

The Company formerly acted as the agent of AAH Pharmaceuticals Limited. On 21 October 1991 the Company changed its name from Vestric Limited to Fielden & Ashworth Limited. It was then acquired by BICC plc on 4 November 1991 to act as an investment holding company.

Details of important events affecting the Company which have taken place since 31 March 1992 are given in note 15 to the accounts.

Results and dividends

The accounts of the Company appear on pages 4 to 16. An interim dividend of £5,133,000 (1991 £1,344,000) was paid on 9 March 1992. No final dividend is proposed for the year (1991 £5,450,000), leaving a retained profit for the year of £18,000 (1991: deficit of £1,344,000) to be transferred to reserves.

An interim dividend of £9,000,000 in respect of the year ending 31 March 1993 was paid on 30 September 1992.

Auditors

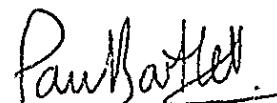

STATEMENT OF ACCOUNTING POLICIES

A summary of the principal group accounting policies, all of which have been applied consistently throughout the year, is set out below.

1. Basis of accounting

The accounts have been prepared under the historical cost convention and in accordance with applicable accounting standards.

The Company is a wholly owned subsidiary of BICC plc, which is incorporated in the UK. The Company is exempt by virtue of S.228 of the Companies Act 1985 from the requirement to prepare group accounts.

2. Taxation.

Deferred Taxation is provided using the liability method at the rates ruling at the year end. Provision is not made for taxation which would be payable if the retained profits of overseas subsidiary and associated undertakings were remitted to the UK.

Advance Corporation Tax payable on dividends paid or provided is written off, except where recoverability against Corporation Tax previously paid or Corporation Tax payable is reasonably assured.

3. Investments

Fixed asset investments are shown at cost less provisions for permanent diminution in value.

4. Income from shares

Dividends on shares in subsidiary undertakings are recognised in the accounts of the Company once they have been declared.

14. Other matters

None of the directors received emoluments for their services to the Company.

The Company had no employees either during the year, or during the prior year.

The audit fee is borne by BICC plc, the ultimate parent company.

15. Subsequent events

On 8 May 1992 the issued share capital of the Company was increased by the issue of 44,898,417 "B" shares of £1 each for £44,898,417 cash to BICC plc, the immediate parent company. The Company used the proceeds to subscribe £44,898,417 for ordinary shares in BOIL, a subsidiary undertaking of the Company.

On 18 September 1992 the authorised share capital of the Company was increased to £450,000,000 and the issued share capital of the Company was increased by the issue of 25,601,583 "B" shares of £1 each for £25,601,583 cash to BICC plc, the immediate parent company. The Company used the proceeds to subscribe £25,601,583 for ordinary shares in BOIL.

On 17 November 1992 the issued share capital of the Company was increased by the issue of 18,500,000 "B" shares of £1 each for £18,500,000 cash to BICC plc, the immediate parent company. The Company used the proceeds to subscribe £18,500,000 for ordinary shares in BOIL.

16. Comparative amounts

The accounts for the year ended 31 March 1991 were audited by a firm other than Arthur Andersen.

17. Ultimate parent company

The Company's ultimate parent company is BICC plc which is registered in England and Wales.

The only group in which the results of the Company are consolidated is that headed by BICC plc. The consolidated accounts of BICC Group are available to the public and may be obtained from Devonshire House, Mayfair Place, London W1X 5FH.
