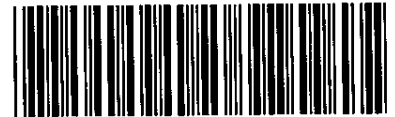

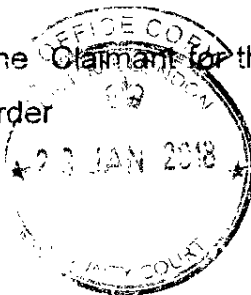

- (4) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
- (5) the hearing date fixed for the 11<sup>th</sup> January 2018 be vacated

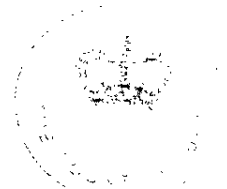
