

AGREEMENT

- hereinafter referred to as "**INSURED PARTY**" -

Date 15 December 2023

COMMERZFACTORING, ORIGINATOR and the INSURED PARTY have entered into an assignment agreement on 27 June 2023, whereby the ORIGINATOR with the consent of the INSURED PARTY, assigned (*tritt hiermit ab*) to COMMERZFACTORING, all or any of its present and future claims arising from the credit insurance agreement with Atradius Kreditversicherung, Niederlassung der Atradius Crédito y Caución S.A. de Seguros y Reaseguros, Spain (hereinafter referred to as the "**Assignment Agreement**"). This Agreement replaces and supersedes in its entirety the Assignment Agreement.

The ORIGINATOR hereby, with the consent of the INSURED PARTY, assigns (*tritt hiermit ab*) to COMMERZFACTORING, all or any of its present and future claims arising from the credit insurance agreement with

Atradius Kreditversicherung, Niederlassung der Atradius Crédito y Caución S.A. de Seguros y
Reaseguros, Spain
Opladener Str. 14, 50679 Köln, Germany
- hereinafter referred to as "**CREDIT INSURER**" -
(insurance policy number **415688**, sub-policy **445921** and **1272578**).

COMMERZFACTORING accepts (*nimmt an*) this assignment.


At the same time, each of the ORIGINATOR and the INSURED PARTY authorizes the CREDIT INSURER to add COMMERZFACTORING as a loss payee (*Zahlungsempfänger*) to the credit insurance agreement and inform COMMERZFACTORING directly of its limit decisions. COMMERZFACTORING and the CREDIT INSURER are entitled to, as necessary, exchange any information in this respect.

The ORIGINATOR undertakes that it will not create or permit to subsist any mortgage, charge, assignment by way of security, pledge, lien or other security interest having a similar effect over any claims arising from the credit insurance agreement described above without the prior written consent of CommerzFactoring.

This Agreement is governed by German law. The courts in Mainz, Germany shall have jurisdiction.

If any provision of this Agreement is or become invalid in full or in part, the validity of the remaining provisions will not be affected thereby. The invalid provision shall be replaced by the provision which is valid and effective and comes closest to the economic intention of the parties. The same principles shall apply if this agreement contains a gap.
