INTRODUCTION

Lewis U.K. Limited (Entity) entered members' voluntary liquidation on 20 January 2021. Emma Cray and Steven Sherry were appointed joint liquidators of the Entity (Liquidators).

The directors' Declaration of Solvency showed that the Entity had no liabilities.

The Liquidators have not received any claims in the liquidation.

HM Revenue & Customs ("HMRC"):

Following their appointment, the Liquidators wrote to HMRC to inform them of the liquidation and to request details of any outstanding liabilities. In the wake of the Covid-19 pandemic, we are aware of delays in receiving clearance from HMRC.

We have continued to chase clearance and eventually received confirmation in November 2021 from HMRC that the Entity has no outstanding tax liabilities and that they have no objection to the liquidation being closed.

Distributions to Members:

As there were no assets to distribute, a distribution in specie comprising any other assets was made to the Member of the Entity on 7 January 2022. A notional value of £1 was attributed to the distribution to cover any other assets of the Entity.
