

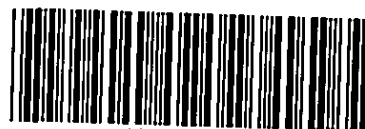

## **REPORT OF THE TRUSTEES OF THE INTERNATIONAL FELLOWSHIP OF EVANGELICAL STUDENTS For the year ended 31 December 2009**

The trustees of the International Fellowship of Evangelical Students – IFES (UK) – have pleasure in presenting their annual report and the audited accounts for the year ended 31 December 2009. References to IFES refer to the combined activities of IFES (UK) and IFES (Switzerland).

### **OBJECTIVES AND ACTIVITIES**

#### **About IFES**

The International Fellowship of Evangelical Students (IFES) is global community of indigenous student movements, called to engage the university with the good news of Jesus Christ. References to IFES in the report and accounts refer to the combined activities of IFES (UK) and IFES (Switzerland).

#### **What IFES believes**

The IFES doctrinal basis is the central truths of Christianity, as revealed in Scripture, including:

- the unity of the Father, Son and Holy Spirit in the Godhead
- the sovereignty of God in creation, revelation, redemption and final judgement
- the divine inspiration and entire trustworthiness of Holy Scripture, as originally given, and its supreme authority in all matters of faith and conduct
- the universal sinfulness and guilt of all people since the fall, rendering them subject to God's wrath and condemnation
- redemption from the guilt, penalty, dominion and pollution of sin, solely through the sacrificial death (as our representative and substitute) of the Lord Jesus Christ, the incarnate Son of God
- the bodily resurrection of the Lord Jesus Christ from the dead and his ascension to the right hand of God the Father
- the presence and power of the Holy Spirit in the work of regeneration
- the justification of the sinner by the grace of God through faith alone
- the indwelling and work of the Holy Spirit in the believer
- the one holy universal Church which is the body of Christ and to which all true believers belong
- the expectation of the personal return of the Lord Jesus Christ

#### **IFES vision to 2020 – living stones**

In 2007, seven hundred students, staff and other IFES stakeholders from around the world forged a new vision to take the organisation through to 2020: students built into communities of disciples, transformed by the gospel and influencing the university, the church and society for the glory of Christ.

Today, IFES works with about 500,000 students annually. Recognising the opportunity contained in IFES' huge student base, the vision of living stones is to release student initiative with a view to doubling the number of active, committed members of IFES groups who are influencing their universities and societies for Christ. Students are at the centre of this vision: students reaching students with the good news of Jesus Christ, students growing into life-long disciples of Christ, students serving and strengthening the church.

#### **Strategic priorities**

To meet this goal of growth and depth of impact, IFES is focusing on six key areas, with the aim of releasing student initiative at the heart of all the strategic priorities.

1. Communicating the good news of Jesus Christ – creatively and clearly to campuses throughout the world, in word, in action and through relationships, within and across cultures.
2. Strengthening leadership and formación – through leaders of integrity, impacting the church, the university, all of society.
3. Promoting student-graduate integration – nurturing life-long disciples, committed to student ministry and to being witnesses in the workplace and society.
4. Building sustainable support – through a growing wave of indigenous generosity and involvement.
5. Addressing current global issues – as students, united with the global body of Christ, responding to contemporary challenges from a Christian perspective.
6. Engaging the university – constructively and boldly, with carefully-developed biblical worldviews, demonstrating the integration of faith, life and academic disciplines.

Every aspect of IFES life will be surrounded and supported by three core commitments of Scripture engagement, community and prayer.

### **Public benefit**

As stated above, IFES' overall objective is to help students bear witness to Christ and his teaching, applying it to every aspect of life in every area of society. This includes equipping them to demonstrate the love of God in practical, tangible ways. For example, in Africa there is a strong programme of educating young people concerning HIV/AIDS, and many IFES groups regularly assist the poor and disadvantaged in their context.

As we encourage Christian students to be faithful to their God, and to share that faith with others, the benefit extends beyond the individual and produces leaders in society who promote ethical standards and have a positive influence on their context. Whilst we would like everyone to embrace Christian values and beliefs, we respect the rights of others to hold differing viewpoints and would never coerce acceptance of our views.

IFES works worldwide, wherever there are universities and in whatever countries we have permission to enter. We believe in indigenous leadership, and strive to ensure that wherever possible nationals who know the local context lead the movements. There are no membership fees, and anyone who is interested is welcome to join in all activities.

The Trustees confirm they have complied with their duty under section 4 of the Charities Act 2006 to have due regard to public benefit guidance published by the Commission.

### **Key areas of focus in 2009**

There is incredible breadth to the IFES ministry across more than 150 countries, so the following section seeks to highlight some key themes from 2009 and gives a number of examples and testimonies from different levels of the organisation, including regional and international events, as well as activities carried out by the national movements that we support.

- **Developing leaders of integrity to face global challenges and transform society**

Many of our strategic priorities depend on strong leadership skills, both in students and staff members. If, for example, we are to address global issues, we need people to lead the student movements who are well equipped with skills and resources to mobilize students. Leadership development takes place in day-to-day ministry as staff and students meet together, as well as through specific events. In 2009 this included many national events organised by different movements, as well as key regional events, such as the IFES Europe Student Leadership Formación held in Poland (28 July- 8 August), sub-regional staff and student training in Latin

America, and the Centre for African Contemporary Christianity, which is explained in more detail below.

**Ukraine:** Sergiy is a student leader in CCX (the IFES movement in Ukraine). He recently attended a student leadership conference that took place in Kyiv, the Ukrainian capital. He says, *'Particularly I wanted to know what it means to be a Christian leader, what character traits this leader should have. I wanted to grow deeper in my relationship with God. I made a commitment to grow as a leader and be involved in CCX during my university years.'*

- **Building firm foundations throughout the Fellowship**

IFES recognises that strong growth needs firm foundations, so we will invest in identifying and initiating excellence and best practice in governance, organisational development, global partnerships, human resources and pastoral care, and research and innovation.

**Francophone Africa:** Another session of the Centre for African Contemporary Christianity was held in 2009 for staff in Francophone Africa. Its goals include equipping participants to train emerging student leaders, and enabling them to think critically and analytically, within a sound biblical framework, about national and global issues. One leader, commenting on how those attending were required to undertake domestic chores, said that the training equips participants to be 'models of transformation'.

**South Asia:** In April 2009, an 'Honour, Encourage and Recognise' conference took place for the female staff of UESI India and the wives of male staff. The goal was to encourage and equip women in ministry, recognising that they may have special needs that can be overlooked in some contexts.

**South Africa and the UK:** The IFES movement in South Africa offers its students the opportunity to serve God after graduation, working alongside SCO ministry in universities or high schools. Papi, the SCO staffworker who oversees this short-term experience in mission (STEM) scheme, attended a training week of Relay (the equivalent of STEM in Britain). He shares how it helped him have a broader picture and gave him new ideas that he can adapt to the South African context.

- **Mission that shows God's love in word and deed**

**Caribbean:** In mid-2009, 20 students and staff from eight countries took part in the second Dominica Missions Project, where IFES movements in the Caribbean are seeking to re-pioneer the student ministry. About 40 students and teachers from Dominica received training and the students were also trained as part of the 'Free' Project, which distributes contemporary versions of Mark's gospel without charge, providing opportunities for discussion with those not a part of the movement.

**Mexico:** A missions convention, VIVE 2009, was held by COMPA (the IFES movement in Mexico) hosting over 900 participants from all over Mexico and from neighbouring countries. VIVE 2009 gathered and not only students, but also over 200 professionals and church members. The goal was to encourage a holistic missions outlook both within the churches and in the student context. Participants were challenged to see God glorified and his kingdom expanded through the proclamation of the gospel and the service of Christians in their context and in the world.

**Central Asia:** Mission has become very practical in Central Asia. A friend there writes. *'Because we are women in a mainly Muslim country, our program must be aimed at female*

*university students. We have invited local Christian doctors to run weekly sessions with us on topics like HIV/AIDS, love, drugs, addiction and abortion. These are issues that no-one talks about publicly. Some topics are so sensitive that we try to include the mothers of the students in order to gain their trust. These are problems that can only find their solution in the healing power of Christ '*

- **Resourcing students to communicate the good news of Jesus Christ**

**Europe:** Glowing reports come from many countries throughout Europe regarding the effects of the training the emerging evangelists received while hosted at UK-based week-long evangelistic missions throughout January, February and March. We are especially pleased to hear how the student movement in Hungary has eagerly responded, not only to their newly trained evangelists, but also to a pair of students now have a vision for small group evangelistic Bible studies. The Hungarian movement is has produced a website where it advertises evangelistic events, the two students have trained others and the number of new Bible studies continues to grow. They are now eager to produce materials in their own language, for their own context.

**Middle East and North Africa:** Students from six countries in the MENA region met in Jordan, with high expectations and a desire for a deeper understanding of the word of God. With speakers from every participating country and lectures that covered a broad range of topics, students were equipped with the necessary tools to motivate them to invest more time in studying the Bible and applying it to their lives. In addition, they were encouraged to spread this new profound insight amongst others in their universities, churches and small groups.

**Papua New Guinea:** D, a recent graduate of TCSF-PNG, the IFES movement in Papua New Guinea, speaks sadly of her difficult childhood and her anger towards her father that deeply affected her as a teenager. Through her involvement with TSCF-PNG, however, she learned that her heavenly Father is different from her earthly father - that God loves her deeply, unconditionally. Now she has graduated, she volunteers as a worker with high school students, hoping that she can share the love she has received with them.

**International Service Centre:** Changes in the International Service Centre structure have taken place over the past year in order to facilitate better communication throughout the IFES Fellowship. A new Global Communications team has been formed, including the appointment of a Digital Services Manager. This has given additional energy to developing our use of the internet and social media to facilitate increased networking, discussion and interaction and to increase the number of students who engage directly with IFES. This will continue to be an area of major focus in 2010.

At the same time we have also changed the way we manage our fundraising. Previously all of our fundraising has been run from our International Service Centre in Oxford. We want to increase our fundraising capacity and so we are now establishing dedicated Supporter Relations teams in the UK and USA (together the UK and USA account for more than 80% of IFES income) and launching an Indigenous Support Development (ISD) program which aims to help national movements and IFES regions to raise more funds in-country. Funding has been received enabling us to move forward with the ISD program and we anticipate one outcome will be the establishment of fundraising functions in other IFES regions in the coming years.

### **Key areas of focus for 2010**

A top priority in 2010 will continue to be the communication and dissemination of the Living Stones vision, and working with regional staff and national movements to develop implementation plans.

to achieve the goals of this vision. Staff around the Fellowship invest crucial time, expertise and experience in nurturing, training and equipping students in order to release their creative energy and initiative as ambassadors of Christ's kingdom, for this generation and those to come.

- **Vision conference:** A key focus for the last part of 2009 was preparations for the Living Stones Conference in early 2010. All movements worldwide were invited to send representatives to the conference, usually the general secretary of the movement. The purpose of the conference is to ensure that every movement both understood IFES Living Stones vision, and was equipped to implement it in the particular contexts of their countries. In addition to teaching sessions, small group discussions and sharing opportunities in the evenings will ensure that all participants can learn from one another and that best practice is communicated. The focus will be on each movement developing concrete plans towards the vision that can be implemented over the coming two years.
- **Around the Fellowship:** IFES will continue working towards making the living stones vision a reality and equipping our students, staff and movements through focussed events, training and ministry initiatives on a regional and international level. Such activities planned for 2010 include the following:
  - a consultation on Islam in Thailand in September;
  - publishing and resource development, governance training, a conference on reconciliation, and training of trainers for the HIV/ AIDS related work in Africa;
  - focussed events for both graduates and governing boards in the Middle East, for student formación in Eurasia and for staff in South Asia;
  - continued commitment to strengthening networks of students and staff in Europe with a passion for particular aspects of ministry, including evangelism and expository preaching

The trustees have pleasure in presenting their report and the accounts for the year ended 31 December 2009.

## **STRUCTURE, GOVERNANCE AND MANAGEMENT**

The company's governing document is its Memorandum and Articles of Association. Members must signify in writing their agreement with the Doctrinal Basis of the company. Reference and administrative details can be found on pages 31 and 32.

### **Structure and decision-making process**

The company will be overseen by its board of directors and is managed by the senior officers of the company. The directors of the company are the same as those of IFES (Switzerland).

For internal organisational purposes, IFES divides the world into eleven regions. Each region is directed by a regional secretary who manages expenditure in their region. For each region, the direct charitable expenditure represents staff, projects and events which are located in the region and focused on working towards the objectives of IFES, as laid out in this report.

In addition to direct charitable expenditure, each regional secretary may recommend the payments of partnership grants to IFES-linked national movements within their region. The purpose of these grants is primarily to enable the employment of a national staff worker - a key factor in the growth and indigenisation of a national movement.

Continued payment of a partnership grant is dependent on the movement providing an annual report of how the money has been used and how this has helped progress towards the IFES objectives. In addition to these reports, regional secretaries monitor the use of the partnership grant during the year. Our aim is to gradually reduce these partnership grants as the national movement becomes better established and more financially self-sufficient.

The administration and fundraising work of IFES is carried out in the International Service Centre, which is directed by the Chief Administrative Officer.

### **Appointment, induction and training of trustees**

The process for the training and appointment of trustees mirrors that of IFES (Switzerland).

- The members of the IEC (International Executive Committee of IFES (Switzerland)) are elected by the IFES International General Committee following regional nominations. At least two names are nominated for each region and then the Nominations Committee, which is a sub-committee of the IEC, recommends a candidate from each region giving regard to background, gender, age and skills in order to achieve the required skills mix. These new members of the IEC will also be appointed as Directors of IFES (UK). The aim is to have representation on the IEC from theologians, business people, and people involved in student ministry. Each member of the IEC will serve a four year term which may be renewed for a second term.
- Immediately following appointment, orientation training will be given to new trustees with a general overview of the Fellowship by the General Secretary, a financial overview by the Head of Finance, and a general introduction to the IEC/Board of IFES (UK) by the Chair. They will also be given specific training on the role and responsibilities of trustees of a UK charity.
- The new trustees will also be provided with key documents – a copy of the Memorandum and Articles of IFES (UK), and a copy of 'Inner Workings' which works out the policies and procedures of the Fellowship. The trustees are encouraged to attend IFES events and to become a member of the Regional Support Group in the region they represent. Other ad hoc training or orientation is given as required.

**Related charity**

IFES (UK) has a related charity, International Fellowship of Evangelical Students, which is registered in Switzerland. Principal contact addresses are the same as for IFES (UK). The principal financial activity of IFES (Switzerland) is to receive donations on behalf of IFES (UK) and pass them on. IFES (UK) donated \$15,755 (2008 \$3,349) to IFES (Switzerland) during 2009. It also received \$73,405 in grants from IFES (Switzerland) in 2009 (2008 \$366,062).

**Risk management**

A major review of the risk register was undertaken in 2008 including asking the regional secretaries to undertake an assessment of the risks in their region. Prior to regional secretaries being asked to assess risk they were given training on risk management. Seventy-three risks were identified at an international level with further risks identified in different regions. These risks were rated for probability and impact.

Control systems already in place to mitigate risks were recognized, and new control systems were identified where sufficient systems were not already established. The Finance Committee approved the risk register for implementation.

The major risks identified included inadequate oversight of personnel issues; weak plans, targets and budgets; loss of tax status in the United States; failure of bankers, and overseas staff being affected by exchange movements. Plans are being put in place to mitigate our exposure to these risks. Major changes in the risk register will be reviewed annually.

In 2009 no new risks related to ongoing work were identified though work was undertaken to identify risks related to the property project being undertaken. Risks identified in this case included failure to secure the property and failure to raise sufficient funds.

The trustees confirm that they continue to be satisfied that adequate control actions and monitoring processes are in place to manage our exposure to major risks.

**Statement of Directors' Responsibilities**

The directors are responsible for preparing the Directors' Report and the financial statements in accordance with applicable law and regulations.

Company law requires the directors to prepare financial statements for each financial year. Under that law they have elected to prepare the financial statements in accordance with applicable law (UK Generally Accepted Accounting Practice applicable to Smaller Entities)

Under company law the directors must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the company and of the income and expenditure of the company for that period. In preparing these financial statements, the directors are required to:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

The directors are responsible for keeping adequate accounting records that are sufficient to show and explain the company's transactions and disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the financial statements comply



with the Companies Act 2006. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

So far as the Directors are aware, there is no relevant audit information (information needed by the company's auditors in connection with preparing their report) of which the charitable company's auditors are unaware; and each Director has taken all steps that they ought to have taken as a director in order to make themselves aware of relevant audit information and to establish that the charitable company's auditors are aware of that information.

**Taxation status of the company**

The company, as a charity, registered number 247919, is exempt from taxation under Section 360 of the Income and Corporation Taxes Act 1988.

## FINANCIAL REVIEW

The results of the company for the year ended 31 December 2009 are set out in the accounts on pages 13 to 28.

Donation income to IFES (UK) was \$6,273,663 (\$6,791,198 in 2008). This enabled direct charitable expenditure of \$5,016,246 to further the objects of the Fellowship. Total donation income in 2009 for IFES (UK) and IFES (Switzerland) (less intercompany transfers) was \$6,500,391 compared to \$6,638,650 in 2008, a decrease of 2%. Total charitable expenditure decreased by 14% from \$5,843,485 to \$4,996,827 with 89% of the 2009 figure being direct costs and 10% cost of generating funds and 1% governance.

We acknowledge that 2009 was a challenging financial year for IFES as it was for many other organisations. We made the strategic decision to cut projects and maintain staffing, as we consider our staff are critical to our work. In support of this decision we decided to be willing to use up to \$200,000 from our General Fund if required. We thank our Finance Committee for their support and wise advice during this difficult time.

The Fellowship makes payments through 'transmission funds' These are donations for activities that are not part of IFES' core activities but are within IFES' charitable objects. Payments made to national movements and other external bodies are treated as grants and are included in the 'grants payable' figure of \$1,791,234. IFES transfers these payments as received after deduction of a service charge. Recipients are expected to make their own arrangements with local tax authorities to ensure that they meet their responsibilities in that area.

The Fellowship uses a defined contribution pension scheme. It is part of group arrangements under the Trusteeship of Global Connections (formerly the Evangelical Missionary Alliance). Legal & General Assurance Society Limited runs the scheme. The scheme consists of two parts, an 'approved' scheme for employees who are subject to UK tax, and an 'unapproved' scheme for those who are not. Pension costs charged in the Statement of Financial Activities represent the contributions payable by the Fellowship in the year.

### Reserves policy

IFES holds reserves for the following reasons:

1. to fund working capital
2. to fund operational activities in the event of shortfalls in income
3. to set aside funds to invest in the longer term development of the organisation.

IFES has set a target range for the General Fund Balance to be between 10 and 25% of the annual operational budget. Based on the 2010 budget for the Fellowship, this would require a general fund balance of between \$530,555 and \$1,326,387. At the end of 2009, the general fund was \$303,509. Additionally there were general funds held in IFES (Switzerland) of \$619,834. Across the Fellowship there was therefore a total of \$923,343 which was in the middle of the target range, being 17.4% of the operational budget.

## **Investments**

### Short term investments

The following funds will only be invested for a maximum of three months as they may be required in the short term: transmission funds, priority funds, provisional funds, the B fund, and general funds being held to fund operational activities in the event of shortfalls in income.

In keeping with our reasons for holding these funds, IFES seeks to maintain high liquidity of investments. Given this requirement we seek to achieve as high a return as is feasible while maintaining the security of the assets. To achieve this, IFES will invest with institutions that have a high security rating in fixed interest term deposits.

Funds held in the Urbana Fund and the Strategy fund not needed in the current financial year will be invested for the period that they are not required. IFES will seek to protect the capital of these funds. To achieve this, IFES will invest with institutions that have a high security rating in fixed interest term deposits.

### Longer term investments

Investment in freehold (or similar) property will be considered where it would significantly reduce the ongoing operational costs of the organisation or where it would enable the retention of senior staff. Funds which can be used for this purpose are: the designated property fund and general funds greater than those required to fund operational activity in the event of a shortfall.

Other funds that are being held for the long term use of the charity (where the capital is not required within the next five years) will be invested in a mixture of bonds and equities. IFES currently holds no funds on this basis and the Treasurer in consultation with the Head of Finance will decide the appropriate mixture at the time when it has such funds to invest, given its desire to maximise returns while maintaining the value of the capital on a longer term basis.

### Currencies

The general funds that are being held to maintain operational activities in the event of a shortfall, are held in a mixture of Sterling, Euros and Dollars in relation to the proportion of budgeted operational costs that are in these currencies. Other funds are maintained in the currency that will be expended.

### General

The investment strategy will be reviewed annually in light of IFES needs at the time, anticipated needs for the future, the types of fund being held and current market conditions.

We seek to avoid investing in companies about which we have ethical concerns eg armaments, tobacco, gambling and alcohol, these also being particularly sensitive to students.

The charity holds funds in the following institutions: US Bank, HSBC, Natwest, CAF bank and AIB. It seeks to ensure that the Fitch short term debt rating for institutions where it holds funds is F1+.

There are no restrictions on the Fellowship's power to invest.

## **APPOINTMENT OF AUDITORS**

Critchleys Accountants LLP, who were appointed during the year, have signified their willingness to continue in office and a resolution proposing their re-appointment will be put to the forthcoming annual general meeting.

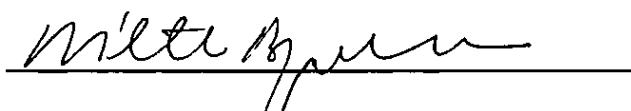

**1. ACCOUNTING POLICIES**

**(a) BASIS OF PREPARATION**

The accounts are drawn up in accordance with applicable accounting standards and the Statement of Recommended Practice Accounting by Charities (2005)<sup>1</sup>. Monetary values are calculated under the historical cost convention, as modified by the revaluation of investments. The accounts have been prepared on a going concern basis.

**(b) SCOPE OF ACCOUNTS**

IFES is a worldwide affiliation of autonomous national student movements. Direct bilateral arrangements for co-operation between two or more national student movements, including the secondment of staff, are not accounted for by IFES. The accounts include IFES Regional Offices and associated staff and exclude autonomous national student movements.

**(c) INCOMING RESOURCES**

Donations received under Gift Aid, and other donations, are recognised as income when received. The tax recoverable under Gift Aid is recognised as income when it becomes receivable. Resources will not be recognised until the conditions for receipt have been met and there is reasonable assurance of receipt. Conference income is accounted for on a receivable basis. Legacy income is recognised when the charity is advised by the personal representative of an estate that payment will be made and the amount involved can be reliably quantified.

**(d) CURRENCY EXCHANGE**

Assets, liabilities, income and costs expressed in foreign currencies are translated into US dollars at rates of exchange ruling on the date at which the transaction occurs, except for monetary assets and liabilities which are translated at the rate ruling at the balance sheet date. Differences arising on the translation of such items are dealt with in the Statement of Financial Activities.

**(e) DEPRECIATION AND VALUATION OF FIXED ASSETS**

Depreciation is calculated to write off the cost of fixed assets except freehold property on a straight-line basis over their effective useful lives. For computers, office furniture and equipment this is at 25% per annum.

**(f) DISPOSAL OF FIXED ASSETS**

Surpluses and deficits on disposal and depreciation of fixed assets are credited or charged to the Statement of Financial Activities.

**(g) RESOURCES EXPENDED**

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category.

Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

- \* Finance costs are allocated on the basis of all employees worldwide
- \* IT costs are allocated on the basis of office based employees
- \* Facilities costs are allocated on the basis of floor area used
- \* Human resources costs are allocated on the basis of all employees worldwide
- \* Communications costs are allocated on the basis of all employees worldwide
- \* General Management costs are allocated on the basis of office based employees



## NOTES TO THE ACCOUNTS

#### (h) PENSIONS

The Fellowship uses a defined contribution pension scheme. It is part of Group arrangements under the Trusteeship of the Evangelical Missionary Alliance. The scheme is run by Legal & General Assurance Society Limited. The scheme consists of two parts, an "approved" scheme for employees who are subject to UK tax, and an "unapproved" scheme for those who are not.

Pension costs charged in the Statement of Financial Activities represent the contributions payable by the Fellowship in the year

#### (i) INTERNATIONAL MINISTRIES

These are costs associated with the work of IFES that cannot be allocated against a particular region or country, whether due to the international nature of the work or the materiality of the expenditure.

#### (j) COSTS OF GENERATING FUNDS

Costs of generating funds comprise all costs identified as wholly or mainly attributable to the generation of incoming resources other than from charitable activities and include an apportionment of overheads

#### (k) CHARITABLE ACTIVITIES

Costs of charitable activities comprise all costs identified as wholly or mainly attributable to achieving the charitable objects of the charity. These costs include staff costs, wholly or mainly attributable support costs and an apportionment of overhead.

#### (l) GOVERNANCE COSTS

Governance costs comprise all costs identified as wholly or mainly attributable to ensuring the public accountability of the charity and its compliance with regulation. These costs include external audit and trustees' costs.

### FUND ACCOUNTING

The International Fellowship of Evangelical Students has various types of funds for which it is responsible and which require separate disclosure. These are as follows:

#### 1. Restricted Funds

*Transmission Funds.* The Transmission Funds comprise the unexpended balances of donations held to be applied for specific purposes within IFES. A charge for the costs associated with administration was levied on the intended recipients during 2009. This has been shown in the accounts under note 4 as having been recharged to the regions.

*Property Fund.* This fund is given for the purchase of a property. They have not yet been applied for the intended use.

*Provisional Funds.* The activities undertaken from Provisional Funds are those that will only go ahead if specific money has been raised to enable them to do so.

*Priority Funds.* Priority expenditure is for activities that are of sufficient importance to the work of the Fellowship that unrestricted funds will be applied to meet any shortfall in restricted income.

*Vision fund.* This relates to gifts received for the implementation of the Living Stones vision.

*Indigenous Fund Development fund.* This relates to funds received to help national movements build their indigenous support base.

*Other funds.* This includes the Capital Revolving Fund, the B Fund and the Urbana fund. The Capital Revolving fund relates to money designated for the use of making loans to IFES staff.

The interest on the B Fund is transferred to the European region.

The Urbana fund related to offerings received from the 2006 Urbana Conference.

#### 2. Unrestricted Funds

*Strategy Fund.* The Strategy Fund is used to pay for strategic events in the life of the Fellowship, particularly the four yearly World Assembly.

*General Fund.* This fund is made up of donations given for the general work of IFES with no restriction on their application by the donor. Income from this fund is used to offset shortfalls in income for specific purposes in the Priority Fund. The IFES (UK) Trustees may designate these funds for certain purposes but they are not restricted to being used solely for those purposes.

**Transfers between funds**

Transfers between funds are normally made to offset any deficit in a restricted fund that was not likely to be offset by income during 2010.
