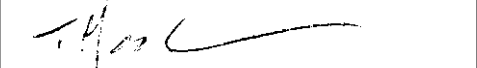

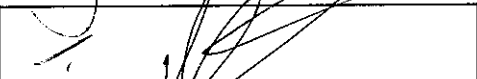

**NOTES**
