ORDER

UPON THE APPLICATION of the Applicant filed on 13 May 2019

AND UPON READING:

- (1) the Witness Statement of Dominic Lee Zoong Wong dated 10 May 2019;
- (2) the written consent of the replacement office-holders, namely Daniel James Mark Smith dated 30 April 2019 and Matthew James Cowlshaw dated 1 May 2019; and

- (3) the written consents of each person who currently holds office with the Applicant, namely Daniel James Mark Smith dated 30 April 2019; Matthew James Cowlshaw dated 1 May 2019; Matthew Wild dated 3 May 2019; Michael John Magnay dated 30 April 2019; Matthew David Smith dated 30 April 2019; Stephen Roland Browne dated 30 April 2019; Richard Michael Hawes dated 7 May 2019; and Philip Stephen Bowers dated 30 April 2019 are also filed herein.

IT IS ORDERED THAT:

1. In relation to the appointments set out in Schedule 1 hereto, Dominic Lee Zoong Wong be removed and Daniel James Mark Smith be appointed as his replacement with the remaining office-holders for each case as detailed in the said Schedule 1 continuing as office-holder in respect of the appointments;
2. In relation to the appointments set out in Schedule 2 hereto, Dominic Lee Zoong Wong be removed and Matthew James Cowlshaw be appointed as his replacement with the remaining office-holder as detailed in the said Schedule 2 continuing as office-holder in respect of the appointments;
4. In relation to the appointments set out in Schedule 3 hereto, Dominic Lee Zoong Wong be removed with the remaining office-holder as detailed in the said Schedule 3 continuing as office-holders in respect of the appointments;
5. That the creditors in each case be notified of any order made under this application by advertisement in the London Gazette within 21 days and at the time of the next statutory reporting requirement for each case;
6. Any creditor in respect of any of the companies listed in Schedules 1 to 3 who has an objection to this order shall have 28 days from the date of advertisement in the London Gazette to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases listed in Schedules 1 to 3 until further or other order by the court;
7. The outgoing officeholder shall file a copy of this order with each of the courts listed in Schedules 1 to 3;
8. The outgoing officeholder shall serve a copy of this order on the Secretary of State;
9. No order as to costs;
10. Such further or other relief as the Honourable Court shall consider just.
