In accordance with Section 519, we detail the following circumstances connected with our ceasing to hold office as auditors of the named Companies that we consider should be brought to the attention of members and/or creditors of the Companies

We had acted as the auditor to the Companies since 1985, and since this time the audit had not been subject to tender. During 2013, the Companies commenced a competitive tender process. Due to the likely forthcoming regulation regarding maximum length of audit tenure and the impact to the perception of independence we declined to participate in the tender process.
