Assets & Liabilities

The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, showed debts due from Sagamore Limited and DB Delaware Holdings (UK) Limited totalling £100 and £1, respectively. The debts have been distributed by set off to the shareholders (see "Distributions" below).

The Company had no known creditors. A notice to creditors to prove their claims in the liquidation was advertised in the London Gazette on 8 November 2016. No creditors were forthcoming as a result of this advertisement.

Tax

All pre-liquidation corporation tax matters were handled by Deutsche Bank who prepared and submitted all outstanding returns up to the date of the commencement of the liquidation to HM Revenue & Customs ("HMRC"). At the request of the Joint Liquidators HMRC subsequently confirmed that the Company had no outstanding corporation tax returns or liabilities, that it would not raise enquiries into any pre or post liquidation periods and that it had no objection to the Liquidators taking steps to bring the liquidation to a conclusion.

A similar assurance was sought and received from HMRC in respect of PAYE. The Company has never been registered for VAT.

Distributions

On 22 January 2018 the Joint Liquidators declared a first and final distribution of the assets of the Company to Sagamore Limited and DB Delaware Holdings (UK) Limited, the company's shareholders.

The distribution was at the rate of £1 per £1 Ordinary share and was effected by set off against the debts of £100 and £1 due from Sagamore Limited and DB Delaware Holdings (UK) Limited, respectively.

Joint Liquidators' remuneration and expenses

A written resolution was passed on 27 October 2016 that the remuneration of the Joint Liquidators be fixed at their normal charging rates according to the time properly spent by them and members of their staff in attending to matters arising in the winding up of the Company.

In the event, the Liquidators' remuneration has been paid by Deutsche Bank AG and accordingly no detailed analysis is included in this report.
