The smallest such group is that headed by SITA Holdings UK Limited, a company registered in England & Wales. In the opinion of the director, SITA Holdings UK Limited controls the company as a result of controlling 100% of the issued share capital of Dixi Sanitation Services UK Limited. At the year end GDF Suez SA was the ultimate controlling party, being the ultimate controlling party of SITA Holdings UK Limited.
