

Insurances means the insurance proceeds from any and all policies and contracts of insurance and reinsurance from time to time taken out or maintained in respect of, or in relation to, the Helicopter in accordance with the Master Hire Purchase Facility Agreement and the Hire Schedule

Master Hire Purchase Facility Agreement means the master hire purchase facility agreement between CHC Helicopters International Inc (CHCI) as principal and agent for itself and others and Bank of Scotland pic (formerly known as "The Governor and Company of the Bank of Scotland) (BoS) dated 31 October 2005 (i) as amended and restated by two deeds of amendment and restatement dated 22 December 2005 and 22 December 2006 respectively (ii) as amended, restated and novated to Heli-One Leasing Inc (the Hirer) by a head deed of novation made between CHC Helicopter Corporation (as successor of CHCI), the Hirer and BoS dated 16 September 2008 (the Deed of Novation) (iii) as amended and restated by a deed of amendment and restatement no 4 dated 28 September 2011 between the Hirer, CHC Helicopter SA and BoS and (iv) as further amended and restated from time to time

Proposed Hirer shall have the meaning given to such term in Clause 10 (Additional Hirers)

Requisition Compensation means all moneys or other compensation from time to time payable in respect of the Compulsory Acquisition of the Helicopter
