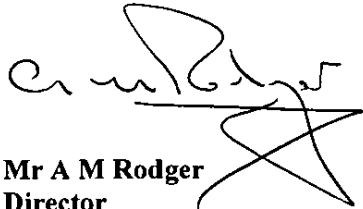
STATEMENT OF DIRECTORS' RESPONSIBILITIES *(continued)*

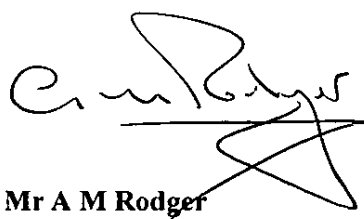
