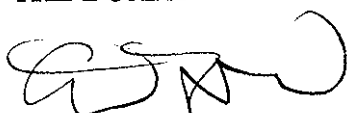
DIVIDEND

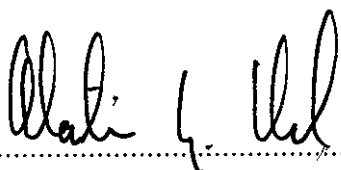
