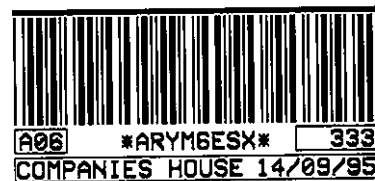

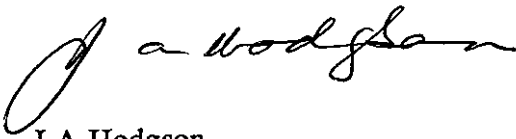

The Company did not trade during the period under review.

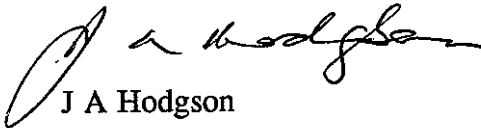
Directors

STATEMENT OF DIRECTORS' RESPONSIBILITIES IN RESPECT OF THE ACCOUNTS

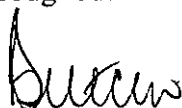

1 Accounting convention

The accounts are prepared in accordance with applicable accounting standards and under the historical cost convention.

2 Called up share capital

The authorised, allotted, called up and fully paid share capital of the company at 28 January 1995 and 29 January 1994 comprised
Ordinary shares of £1 each £100

3 Profit and loss account

The Company has not traded during the period and accordingly has made neither a profit nor a loss. No profit and loss account has therefore been prepared.
