

At a GENERAL MEETING of the above-named Company, duly convened and held at Marygreen Manor Hotel, London Road, Brentwood, Essex CM14 4NR on 24<sup>th</sup> November 1999 at 11.00 a.m. the following resolution was passed as an Ordinary Resolution:-

#### RESOLUTION

That the directors be and are hereby generally and unconditionally authorised pursuant to section 80 of the Companies Act 1985 to exercise the power of the Company to allot relevant securities (within the meaning of section 80 of the Companies Act 1985) up to an aggregate nominal amount of £987,313 to such persons and at such times and on and subject to such terms as the directors shall determine provided that this authority shall unless renewed expire on the conclusion of the next Annual General Meeting of the Company after passing of this resolution, save that the Company may before such expiry make any offer or agreement which would or might require relevant securities to be allotted after such expiry and the directors may allot relevant securities in pursuance of such offer or agreement as if the authority conferred hereby had not expired.
