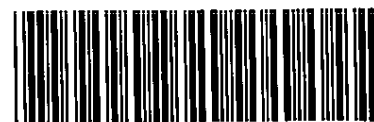

UPON AN APPLICATION of the Applicant by Notice dated 30th September 2009

AND UPON READING the witness statement of the Applicant dated 29th September 2009

IT IS ORDERED

- (1) that the proceedings listed in Schedule A hereto transferred to the Companies Court of the Chancery Division of the High Court for the purpose only of making the orders set out below. As soon as reasonably practicable after the making of this Order, the Applicant shall lodge with each of the Courts mentioned in Schedule A hereto one copy of this Order (as sealed) for each case under the jurisdiction of that Court, for filing on the Court File relating to that case
- (2) that the First Respondent be removed from office with effect from the date of this Order in the proceedings listed in the Schedules hereto and in each such case the

Applicant be and is hereby appointed to replace him

- (3) that the Applicant shall have permission to apply to the Secretary of State for his release until after the expiry of 42 days from the date when the relevant notice referred to in paragraph (5) hereof has been made to the creditors of the relevant estate
- (4) that there be permission to each creditor to apply to vary or discharge this Order insofar as it relates to the estate of which they are a creditor, within 28 days of their being given notice of it
- (5) that the Applicant shall procure that at the first convenient opportunity to do so and in any event within 3 months of the date of the Order a block advertisement in relation to each of the relevant estates shall be placed in the London Gazette containing notification of the following matters:
 - (1) the removal of the First Respondent and the appointment of, and the name of his replacement
 - (2) the fact that the creditors have permission to apply within 28 days after the notice has been advertised to vary or discharge the order made
 - (3) in the case of each bankruptcy and liquidation, that;
 - (a) the costs of complying with a request of the committee or creditor for an account of the First Respondent's administration should be an expense of the insolvency proceedings;
 - (b) the fact that the creditors have the right to object and make representations to the Secretary of State in respect of the First Respondent's release within 28 days after notice has been advertised:

and

- (c) the fact that the First Respondent will be entitled to apply to the Secretary of State for his release within 42 days after the notice has been advertised
- (6) that in relation to the insolvency proceedings listed in the Schedules hereto, and insofar as the Insolvency Act 1986 or the Insolvency Rules 1986 contain any requirement for advertisement the requirement shall be dispensed with save to the extent provided for herein. Insofar as the First Respondent is required by law to give any notice of the removal from office the Applicant is entitled to sign and sign and send any such notice on his behalf
- (7) that the order for costs be as follows:
 - (1) the costs of the Application insofar as attributable to an individual insolvency proceedings are to be fixed and paid in the ordinary way as remuneration costs and expenses of such insolvency;
 - (2) costs which cannot be attributed to an individual insolvency proceeding because they affect all the insolvency proceedings are to be apportioned
 - (3) such costs should not exceed 10% of the assets realised in the particular insolvency or voluntary arrangement
