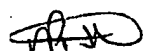

Notes on the Financial Statements

1 Basis of preparation

(a) Compliance with International Financial Reporting Standards

The financial statements of the Company have been prepared in accordance with international accounting standards in conformity with the requirements of the Companies Act 2006. The principal accounting policies applied in the preparation of these financial statements have been consistently applied to all of the years presented, unless otherwise stated.

There were no unendorsed standards effective for the year ended 31 December 2020 affecting these financial statements.

Standards adopted during the year ended 31 December 2020

There were no new accounting standards which were effective from 1 January 2020 that have had a significant impact on the financial statements of the Company. During 2020, the Company adopted a number of interpretations and amendments to standards which had an insignificant effect on the financial statements of the Company.

(b) Future accounting developments

There are no new International Financial Reporting Standards (IFRSs) and amendments thereto effective from 1 January 2021 which are expected to have a significant impact on the financial statements of the Company. However, the International Accounting Standards Board has published a number of minor amendments to IFRSs that are effective from 1 January 2022 and 1 January 2023. The Company expects they will have an insignificant effect, when adopted, on the financial statements.

(c) General information

Canada Crescent Nominees (UK) Limited is a private limited company incorporated in the United Kingdom and registered in England and Wales.

The functional currency of the Company is sterling which is also the presentational currency of the financial statements of the Company.

The financial statements have been prepared on the historical cost basis.

2 Directors' emoluments

The Directors did not receive any emoluments in respect of their services to the Company during the year. The Company has made no loans, guarantees or other such dealings to its Directors and others during the year.

3 Related party transactions

There have been no transactions with related parties requiring disclosure in either the current or prior year. The Company is dormant and all statutory fees are paid by another group undertaking.

The ultimate parent undertaking (which is the ultimate controlling party) and the parent undertaking of the largest group of undertakings for which group financial statements are drawn up and of which the Company is a member is HSBC Holdings plc, and the parent undertaking of the smallest such group is HSBC Bank plc. The immediate holding company is HSBC Bank plc. The result of the Company is included in the group financial statements of HSBC Holdings plc and HSBC Bank plc.
